Des Plaines officers responded to the 2000 block of Pine Street for the report of a domestic battery. Dispatch relayed the offender, Jorge Correa Camacho, left the scene in a vehicle and provided a license plate. Officers arrived on scene and spoke with one of the victims who stated she observed two of her family members having a verbal argument, one of them being Jorge. She then observed Jorge push the other victim in the chest. She then tried to intervene, and Jorge pushed her as well. Officers observed a visible mark to the bicep area of one of the victim's where she stated Jorge grabbed her. The vehicle Jorge left in was located in the 2200 block of Lee Street by other officers and a traffic stop was conducted. Jorge was located in the passenger seat of the vehicle, and he was taken into custody. Jorge was subsequently arrested for 2 counts of Domestic Battery. He was later transported to the Cook County courthouse for a detention hearing.
