Andrew continued to ram both squad cars by alternating between "Drive" and "Reverse". Des Plaines officers extracted the subject from the vehicle where he began to physically resist arrest. He was eventually taken into custody. He is being transported to Skokie Courthouse for further processing.

Suspect was a 2nd vehicle involved in the reckless driving incident above. He was observed doing burnouts and then fled upon DPPD arrival. Des Plaines officers activated their overhead emergency lights and Brandon stopped the vehicle. He was taken into custody and charged before being released.
