NOTEWORTHY INCIDENTS:

OFFENSE: Criminal Damage to Vehicle

Officers responded to the 2000 Block of Pine Street to take a report for a criminal damage to vehicle. The victim reported that sometime overnight their blue Chevrolet was vandalized. Officers reported that they observed a large piece of concrete was thrown into the windshield, cracking it, before rolling off on to the hood.

Officers responded to the 100 Block of Dover Drive in reference to a burglary to vehicle. They spoke with the owner who related that when they left for work in the morning, they observed that it appeared someone had been in their vehicle. Upon closer inspection the owner noticed that the steering column was damaged in a possible attempt to steal the vehicle. The steering column plastic was found on the seat. The owners related that the incident occurred overnight and that the vehicle doors had been left unlocked.

Officers responded to the 900 Block of Elmhurst Road at 6:09 PM to assist the caller with a disruptive subject inside their restaurant. Upon their arrival Devontae Phillips was asked to leave and given a trespass warning by responding officers. At 7:10 PM, officers were again requested at that same location due to Phillips returning to the premise. Officers asked Phillips multiple times to voluntarily leave. Phillips refused to exit the restaurant. Officers then attempted to take Phillips into custody for Trespassing, however Phillips pulled away attempting to defeat the arrest. Officers were able to take Phillips into custody, placed him in handcuffs and transported him to the police department. Phillips was charged with Criminal Trespass to Property and Resisting a Peace Officer. He was bonded out a short time later.

Randazzo was charged with Domestic Battery and sent to the Cook County Court House for a bond hearing.
