Des Plaines officers working the front desk at the station were confronted by subject, Daneil Paska at the front window. Daniel was yelling and swearing at officers and began hitting the safety glass at the desk. One of his strikes caused a crack in the window and Daniel began walking away. By the time officers exited the station, Daniel was in his vehicle leaving. Officers attempted to stop his vehicle however he continued to ignore their emergency lights and sirens, disobeyed several traffic signs and signals and attempted to pull into his residence. Once he finally stopped, officers attempted to take him into custody and he began resisting exiting his vehicle which led to officers taking him to the ground and finally placing him into custody. The officers noted Daniel had a strong odor of alcohol emitting from his breath. The Des Plaines Fire Department was called to the scene out of caution for officers having to fight with Daniel and his intoxication level. While being observed by DPF, officers noted Daniel had bloodshot watery eyes and heavily slurred speech. Officers also observed an open bottle of alcohol in Daniels' vehicle. Daniel was transported to the hospital where he continued to be combative with officers and hospital staff. Daniel was subsequently arrested for Criminal Damage to Property, Fleeing or Attempting to Elude a Peace Officer, Reckless Driving and Driving Under the Influence of Alcohol. He was also cited for Disobeying a Traffic Control Device, Disobeying a Traffic Control Light, Illegal Transportation of Alcoholic Liquor by Driver and Operation of an Uninsured Motor Vehicle. Daniel was cited and released at the hospital with his court information.

On 04/18/2024 the victim walked into the Des Plaines Police Station to report a delayed Domestic Battery. She stated on 03/09/2024 subject, Joshua Miralgio, took a door off the hinges and threw it at her. He then threw a kitchen knife toward her feet which created a small cut on her foot and grabbed her shoulders and arms multiple times creating bruising and marks. Detectives conducted a thorough investigation and on 09/25/2024 Joshua was taken into custody and transported to the Des Plaines Police Station where he was subsequently arrested for Domestic Battery. He was later transported to the Cook County courthouse for a detention hearing.
