The victim related that they located a Facebook post advertising a vehicle for sale. The post requested an online form of payment as a deposit to reserve/see/test drive the vehicle. The victim learned that the post was removed and advised that the vehicle was sold. The victim located another post advertising the same vehicle for sale. At the time of this report, the victim was unable to get their deposit back and communication with the subject who posted the advertisement, has ended.

Officers located surveillance footage that depicts the above described subject running from the scene, northbound. Unknown subjects caused damage to three windows at the residence.

Pratt Ave. suffered a puncture wound and several other lacerations along his left arm. The victim claimed the injuries were a result of his girlfriend, Carrie Hoffman, stabbing him and then fleeing the scene. Carrie and the victim were arguing, and Carrie physically attacked the victim when he requested for her to leave the Airbnb. The victim was transported to a local hospital for non-life-threatening injuries. Carrie Hoffman was taken into custody at approximately 3:24 a.m. on September 29. While walking in the area of 815 E. Oakton St. in Des Plaines. She was transported to the station where upon a search of her person, officers recovered a rock-like substance, suspect crack cocaine from her pocket. On Sept. 30, he was transported to the Skokie Court House for a condition hearing as a result of the active warrant for his arrest.
