On October 1, 2024, at 2:21 a.m., a Des Plaines officer, while on patrol, observed a silver Cadillac Escalade, stopped in the middle of the roadway in the 1300 block of east Oakton St. The officer attempted to make contact with the driver, Danny Esquivel, who was unresponsive in the driver's seat. The officer was ultimately able to wake up Esquivel who showed signs of intoxication. Esquivel smelled of alcohol and was slurring his speech. Officers ordered Esquivel out of the vehicle, he refused and became aggressive with the officers. The officers on scene were able to remove Esquivel from his vehicle and he was taken into custody. A search of his vehicle yielded

miscellaneous handgun ammunition and suspect cannabis. Esquivel was charged with driving under the influence of alcohol, no valid driver's license, operation of an uninsured motor vehicle, resisting a peace officer, FOID card required to possess firearm ammunition. He was given Citation and Notice release form and was released for the Des Plaines Police Department.
