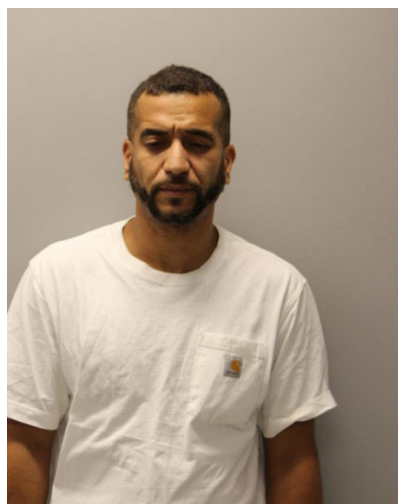

The officer conducted a traffic stop and spoke with the driver, Eric Ballard, and passenger, Marie Judd. Upon searching Eric's information, it was learned he had an active warrant. Eric was taken into custody and he gave permission for Marie to take his vehicle. Officers searched Marie's information to confirm she had a valid

A Des Plaines officer was on patrol in the area of Lee Street and Howard Avenue when he observed a vehicle with expired registration and an equipment violation. The officer stopped the vehicle and spoke with the driver, Anthony Gonzalez, and upon searching his information learned his driver's license was revoked. The officer also observed an open container of alcohol inside the vehicle. Anthony was taken into custody and transported to the Des Plaines Police Station. Upon searching the vehicle, officers located a white powdery substance suspected to be cocaine and two unknown pills not in a prescription container. Once at the station, the officer tested the white powdery substance which tested positive for the probable presence of cocaine. He also tested the pills which tested positive for the probable presence of amphetamine/dextroamphetamine. Anthony was subsequently arrested for 2 counts of Possession of Controlled Substance and Driving on a Revoked License. He was also cited for Expired Registration, Operating a Motor Vehicle with a Registration Plate Cover and Illegal Transportation of Alcohol. He was cited and released from the station with his court information.
