On 09/19/2024 Des Plaines officers responded to Mariano's for the report of a theft. Officers learned a subject, later identified as Herbert Grogg, stole alcohol and other items from the store and was last seen walking north on Mt. Prospect Road. Officers located Herbert in the area and the victim was unable to identify Herbert as the subject who stole the items stating he was wearing different clothes, so he was released. A further investigation of video surveillance footage showed the subject who stole the items had the same features as Herbert. Officers were able to obtain a warrant for Herbert and on 10/07/2024 this agency was contacted by Will County Detention Facility that they had Herbert in custody. Officers went and took custody of Herbert and upon arriving at the police station, they provided Herbert with his Miranda Warnings which he waved and agreed to speak with officers. Herbert ultimately admitted to stealing the items and changing his clothes prior to officers stopping him. He was subsequently arrested for Retail Theft and was transported to court for a detention hearing.
