At approximately 2:59am, Des Plaines Officers were dispatched to 1572 Rand Rd. regarding a burglary in progress. Complainant was the owner of the store and related he was observing 2 subjects break the front glass window before entering the store. Officers arrived on scene and observed the offenders exiting the store and entering a silver in color Toyota Tacoma. Despite officer's activating their emergency lights, the offenders fled over the parkway curb onto Rand Rd. They were involved in a pursuit onto I294 that was eventually terminated by Des Plaines Police. The offender information was given to ISPERN and broadcast to surrounding agencies. At approximately 4:19am, Oak Forest Police Department contacted Des Plaines PD and advised them they had the offending vehicle and the driver in custody. The driver/suspect, now known as Matthew Newbern, was transported back to Des Plaines PD where he was read his Miranda Warnings. Matthew refused to speak to police. The state's attorney's office approved felony charges for burglary, aggravated fleeing and eluding, and a misdemeanor charge for driving on a revoked license. Matthew also had 2x warrants out of Cook County. It should also be noted that other power tools and stolen proceeds were found in the bed of the truck. Various agencies have been in contact with Des Plaines PD and have confirmed the vehicle and the stolen proceeds to belong to various crimes in their towns.
