A Des Plaines officer was on patrol in the 2000 block of Mannheim Road when he observed a white Jeep was traveling approximately 5 MPH and impeding traffic. The officer got behind the vehicle and activated his emergency lights at which time the vehicle attempted to pull over and struck the curb. The officer spoke with the driver, Alvaro Pacheco-Torres, who had a strong odor of alcohol emitting from him breath along with bloodshot water eyes. The officer requested his driver's license and he seemed confused and took some time to locate it. He was unable to provide insurance. The officer requested Alvaro to submit to Standardized Field Sobriety Tests and upon completion he showed visible signs of impairment. Alvaro was taken into custody and transported to the station. Alvaro was subsequently arrested for Driving Under the Influence of Alcohol and was also cited for Driving Below the Speed Limit and Operating an Uninsured Motor Vehicle. 

A Des Plaines officer was on patrol in the 900 block of Oakton Street when he observed a vehicle in the parking lot repeatedly honking its horn. The officer approached the vehicle at which time a woman ran up to the officer crying with blood on her nose and legs stating she was beaten. According to the victim, she and subject, Alejandro Vargas, were traveling from Chicago at which time an argument ensued in the vehicle. Alejandro began punching the victim in the head multiple times. She attempted to call 911 while they were still driving, at which time Alejandro pulled over into a parking lot and continued to punch the victim. He then exited the vehicle and left the scene. Officers searched the area and located Alejandro in the 900 block of W Oakton Street. He was taken into custody and transported to the station. Due to the nature of the charges, the Cook County State's Attorney's Office was contacted and they approved one felony count of Aggravated Domestic Battery. He was later transported to court for a detention hearing.

A Des Plaines officer responded to the area of Pratt Avenue and Mannheim Road for the report of a check wellbeing/a possible vehicle crash. The officer observed a Ford sedan crashed into the rear of a parked vehicle with the air bags deployed in the 1600 block of Pratt Avenue. The officer approached the vehicles and observed them both unoccupied. The registered owner of the Ford was Andrei Stoleru who resided on Pratt Avenue nearby. The officer went to the residence and spoke with Andrei who initially stated he was not involved in the crash and then changed his statement that he was involved. The officer requested his driver's license, insurance information and car keys and Andrei appeared confused and continued to go back and forth inside his residence to try and locate the above items. While speaking with Andrei, the officer detected an odor of alcohol emitting from his breath. The officer requested multiple times for the above documents, however Andrei could not provide it and attempted to give the officer other random cards from inside of his wallet. The officer requested Andrei submit to Standardized Field Sobriety Tests and upon completion showed visible signs of impairment and was taken into custody. At the station, the officer request if Andrei would be willing to submit to a breath alcohol sample. Andrei agreed and his BAC read approximately three times above the legal limit. The officer provided Andrei his Miranda Warnings which he waved agreeing to speak with the officer at which time he admitted to consuming alcohol prior to driving home. Andrei was subsequently arrested for Driving Under the Influence of Alcohol and DUI with a BAC over .08. He was also cited for Failure to Reduce Speed to Avoid an Accident and Operating an Uninsured Motor Vehicle. He was cited and released with his court information.
