Officers were dispatched to the 600 block of Pearson Street to investigate an anonymous tip about a suspicious person possibly involved in a package theft. Upon arrival, officers located a subject who initially identified himself as Junior Lopez in the area matching the description of the subject in the Bolo. Officers reported that they had prior contacts with the subject that they were questioning and knew him to be Gerardo Federico Jr. After running his real name through LEADS, they learned that he had an active warrant from Cook County Sheriff's office. A search incident to his arrest yielded a green leafy substance, suspect cannabis. He was transported to the Des Plaines Police Dept without incident.

At the station, officers confirmed his identity and the warrant via fingerprint identification. Federico
