A Des Plaines officer was on patrol when he observed a white Audi stopped in the middle of the road on a residential street. When the officer approached the vehicle, he observed a subject wearing a mask looking into a parked vehicle nearby. Once the subject saw the officer, he ran back to the Audi and the vehicle began driving away. The officer observed the Audi did not have a rear license plate and he attempted to stop the vehicle. The vehicle began fleeing from the officer and a short pursuit took place before it was terminated. The Audi was last seen east on Dempster Street.

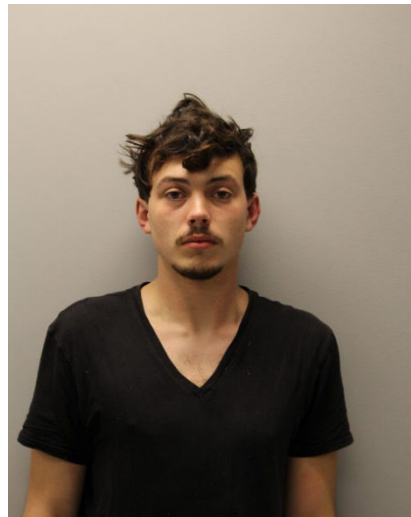

On 11/4/2024 at approximately 9:00 p.m. Des Plaines officers were contacted by the Mount Prospect Police Department stating they were investigating a hit and run crash and the offending vehicle fled the scene. They advised the offending vehicle registered to an address on Fifth Avenue in Des Plaines and requested this agency's assistance. A Des Plaines officer went to the address and observed the offending vehicle parked, running and occupied in the area. The officer observed a subject, later identified as Aidan Tahoe, exit the driver's seat and open the rear passenger door appearing to reach for something.

The officer gave Aidan several warnings to stop reaching in the vehicle which he ignored. The officer then grabbed Aidan's arm and he began tensing up, pulling away and pushed the officer. Aidan then began running from the officer and once the officer caught up to him, he attempted to escort him to the ground to take him into custody at which time Aidan began fighting with the officer. Aidan got up and ran away and the officer lost sight of him behind a residence. At approximately 10:52 p.m. officers received a call reporting a subject with no shirt on was walking north on Fifth Avenue. Officers went to the location and observed Aidan who attempted to run away again. Officers went to take him into custody, and he again tensed his body attempting to physically defeat the arrest. He was eventually taken into custody and transported to the Des Plaines Police Station. Officers went back to the vehicle involved in the hit and run crash and spoke with the female registered owner who was in the passenger side of the vehicle. She stated when officers approached the vehicle Aidan was reaching for his backpack. She gave officers consent to search the vehicle and inside the backpack officers located suspect cannabis, suspect narcotics and drug paraphernalia. Due to the nature of the charges, the Cook County State's Attorney's Office was contacted who approved one felony count of Aggravated Battery to a Peace Officer. Aidan was also arrested for two counts of Possession of Controlled Substance, Possess with Intent to Manufacture/Deliver, two counts of Resisting or Obstructing a Peace Officer and Possession of Cannabis. He was later transported to court for a detention hearing.

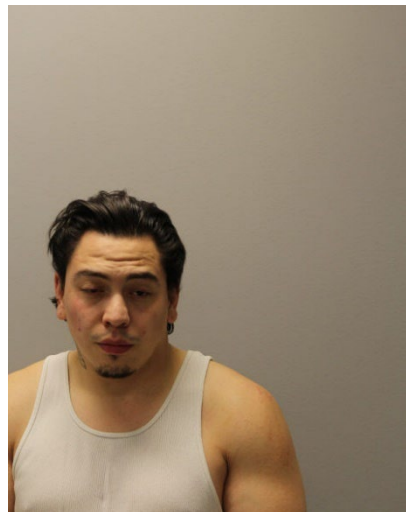

Des Plaines officers responded to the area of Prairie Avenue and Graceland Avenue for the report of a reckless driver in a black Kia Optima speeding through stop signs. An officer observed the vehicle in the area of Graceland Avenue and Willow Avenue and attempted to stop the vehicle at which time it began fleeing through an alley. The vehicle continued to flee until it turned into the Des Plaines City parking garage behind the station and stopped. A male juvenile driver and female juvenile passenger immediately exited the vehicle and were taken into custody. The steering column of the vehicle was damaged. The owner of the vehicle was contacted and stated the vehicle was stolen. The male juvenile was subsequently arrested for one felony count of Possession of Stolen Motor Vehicle and one felony count of Aggravated Fleeing/Attempting to Elude a Peace Officer.

A Des Plaines officer was on patrol in the area of Oakton Street and White Street when he observed a white Dodge Challenger with a headlight out and no front license plate. The Challenger passed the officer, and the driver was observed to be a Hispanic male. The officer attempted to stop the vehicle at which time it sped up and began to flee. The officer continued to pursue the vehicle which was traveling at a high rate of speed and the pursuit was terminated. Des Plaines was later contacted by the Elk Grove Police Department (EGPD) stating the Dodge Challenger was involved in a crash in their town and they had a male and female in custody. Des Plaines officers went to EGPD and spoke with the female in custody who stated subject, Cristian Ramirez, was driving the Challenger. Cristian refused questioning from officers and was transported to the Des Plaines Police Station. Due to the nature of the charges, the Cook County State's Attorney's Office was contacted who approved one felony count of Aggravated Fleeing/Attempting to Elude a Peace Officer. He was also cited for Speeding, Headlight Violation and Improper Lane Usage. He was cited and released with his court information.
