The victim related that they were at a traffic light when the vehicle behind them failed to stop, and rear ended their vehicle. The victim related that the driver was a male subject and identified a subject who officers later identified as Luis Zapata. Officers spoke with Zapata who refused to answer the officers' questions. He related he was not driving the vehicle. While attempting to question Zapata officers noted a strong odor of alcohol emitting from his breath and noted that he was starting to fall asleep while standing up, slurring his speech and swaying back and forth. Zapata refused all standardized testing. He was placed under arrest and taken into custody without incident on suspicion of DUI. A search of the vehicle incident to arrest yielded several open liquor bottles. Zapata was charged with DUI, Failure to Reduce Speed, Illegal Transportation of Alcohol and posted a bond
