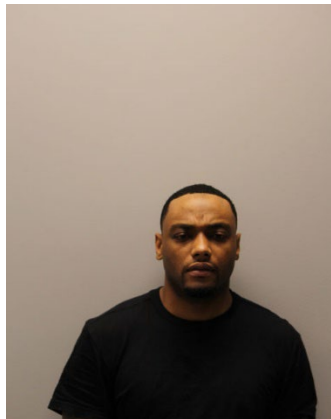

Des Plaines officers responded to the 1400 block of Henry Avenue for the report of vehicles driving recklessly. As officers arrived, they observed two vehicles near Center Street and Henry Avenue with no headlights activated. The officer activated their emergency lights and one of the vehicles increased its speed and began fleeing from the officer while disobeying stop signs. The vehicle eventually lost control and came to a stop at Oakton Street and Lee Street. The driver, Joshua Solis, was taken into custody and subsequently arrested for Fleeing or Attempting to Elude a Peace Officer and Reckless Driving. He was also cited for Wrong Way on a One-Way Street, Disobeying Traffic Control Device x3 and Not Driving on Right Side of the Road.
