The children were transported to Lutheran General Hospital to check their wellbeing. An additional ambulance was requested for Javida and she was additionally transported to LGH. All parties had minor injuries. Javida was requested to submit to a blood and urine test, however she became aggressive with hospital staff so the test was not able to be completed. DCFS was contacted and Javida was requested to come back to DPPD for further processing after being medically released from the hospital. She was charged with multiple felonies, misdemeanors, and traffic violations. Her mugshot is not currently available due to not yet being photographed after being released from the hospital.
