Officers responded to a domestic incident on the 200 block of Cumberland Parkway. Upon their arrival, officers reported hearing yelling within the house and entered through an unlocked door. They observed Nataliya Kline standing outside her bedroom door. Officers spoke with the victim who related that Kline is his roommate and that she, unprovoked, started yelling at him outside his closed bedroom door. The victim stated that Kline then began hitting his door with a hammer eventually breaking down the door yelling at him to leave the house with the hammer raised above her head. While this was happening, the victim stated he contacted 911. The victim further related to officers that when Kline broke down the door he felt threatened and felt he would be hit with the hammer. The victim related he would sign complaints against Kline.

Officers reported that they observed heavy damage to the bedroom door.

Officers spoke with Kline who related that she wanted the victim and his girlfriend out of her house. She further related that she would not leave the victim alone if officers left.

Officers then told Kline she was under arrest and took her custody. She was transported to DPPD

without incident where she was charged with Aggravated Assault and Criminal Trespass to Residence. Due to the domestic nature of the complaint, Kline was sent to bond hearing.
