OFFENSE: Criminal Damage to Property

The victim's Chevrolet vehicle was parked in the 500 Block of Dara James Road overnight when the Unknown Offender(s) smashed the front passenger side window and then ransacked the interior. Although the vehicle had been gone through, it did not appear that anything was missing.

Des Plaines Police responded to the Rivers Casino located in the 3000 Block of S. Des Plaines River Road for an unwanted subject. When officers arrived, they spoke with casino security who stated that while inside the casino, a female subject, later identified as Donna Bonner, was identified by staff as someone who had been previously banned from the property. Casino security approached Bonner in the smoking patio located on the east side of the building, informed her that she had been banned and that she needed to leave. Bonner refused and stayed on the patio while security called 9-1-1. Officers approached Bonner to assist with getting her to leave when she stated she would not be speaking with the officers without a lawyer present. Officers then attempted to get her basic identifying information which she also refused to give. Eventually, Bonner handed the officer paperwork with the name "Donna Bonner" on it. The officer attempted to confirm the information with Bonner but again, she refused to assist. The officer provided the information to the Des Plaines Dispatch who was unable to find record of her in the database. Bonner was notified again that she needed to leave the property or would be trespassing and she did not comply with the officers ordered. Bonner was taken into custody, after which, DP Dispatch located a record with her name which positively alerted to a warrant through the Cook County Sheriff's Police Department. Dispatch confirmed with CCSPD that the warrant was valid and active. Bonner was

transported to the Des Plaines Police station and subsequently arrested for one misdemeanor count each of Obstructing Justice, Criminal Trespass to Real Property, and the Issuance of a Warrant. Bonner was later brought to a Cook County courthouse for a detention hearing.

Des Plaines Police responded to a hotel in the 1200 Block of S. Lee Street regarding a disturbance with one of the female guests, later identified as Mariana Lisitcenco. When the officers arrived, they spoke with the complainant/front desk employee, who stated Lisitcenco was walking around the building with alcohol bottles and trying to enter storage rooms that were off-limits to hotel guests. The complainant provided the corresponding room that Lisitcenco checked in with and the officers went there to make contact. After knocking on the door, Lisitcenco opened and began a conversation with the officers. She stated that she had booked and paid for the room using a credit card belonging to a family member. Lisitcenco provided her identifying information and contact information for the family member. After running her information through the database, the officers were notified that Lisitcenco had an active order of protection in her name with the petitioner being listed as the name of the family member she provided. Lisitcenco confirmed that she had been in contact with the petitioner several times that day. Lisitcenco was taken into custody and transported to the Des Plaines Police station where she was subsequently arrested for one misdemeanor count of Violation of an Order of Protection. Lisitcenco was later brought to a Cook County courthouse for a detention hearing.
