NOTEWORTHY INCIDENTS:

OFFENSE: Hit and Run Accident **DATE/TIME:** 01/10/2025 7:09 a.m.

LOCATION: Des Plaines River Road / Devon Avenue

Both the victim and the Unknown Offender were southbound on Des Plaines River Road approaching the red light in the left turn lane at Devon Avenue. The victim stopped for the red light when the offender failed to reduce speed and struck the victim in the rear bumper. The offending vehicle appeared to be a black Toyota sedan being driven by a female that fled east on Devon Avenue.
