NOTEWORTHY INCIDENTS:

OFFENSE: Hit and Run Accident
DATE/TIME: 01/23/2025 7:00 p.m. – 01/24/2025 7:00 a.m.
LOCATION: Howard Avenue / Ash Street
REPORT #: 25-00407

The victim's Subaru Outback was legally parked on Howard Avenue just east of Ash Street during the above time frame when the Unknown Offender struck the vehicle's driver's side. As a result of the accident, a small piece of red plastic from the offending vehicle broke off and was left at the scene. The offender fled the area without providing information.

The victim was traveling west on Miner Street approaching the intersection with Pearson Street in the outside lane of travel with a noted solid green light while the Unknown Offender was traveling in the opposite direction, approaching the same intersection, intending to turn north on Pearson Street. At the intersection, the offender failed to yield the right of way and turned in front of the victim causing a collision with the victim's front bumper. The offending, tan-colored sedan driven by a male subject then fled the scene.

The victim's black Chrysler 300 was parked in a driveway in the 100 Block of Fremont Avenue overnight when the Unknown Offender(s) stole the vehicle. The victim reported that while attempting to start the vehicle using a phone application, the victim noted the gas gauge reading was low and the location of the car was currently in the 5600 Block of

S. Sacramento Avenue in Chicago, IL. The officer observed broken glass on the ground near where the vehicle was parked prior to the theft.

The victim and the Unknown Offender were both navigating the traffic circle at 1 Cumberland Circle near Broadway Street in the outside lane of travel. At Broadway Street, the victim slowed to exit when the offender failed to reduce speed and struck the victim's rear bumper. After the collision, the offender then struck a sign on the parkway between Broadway Street and Golf Road before fleeing eastbound on Golf Road. The vehicle was reported to be a white Jeep SUV.

The window appeared to have been shattered using a brick and when the offender's made entry, they stole approximately \$2,000.00 from the cash register and approximately thirty nicotine vapes. The surveillance of the incident showed four male unknown subjects all wearing black hooded sweatshirts and face masks.

The victim and Unknown Offender were both in line at a deli located in the 1400 Block of S. Lee Street when the offender began yelling and threatening physical harm to the victim. On more than one occasion, the offender approached the victim and put his face near the victim's face. The offender paid for his items and left the store without further incident and is described as a male subject of average height and build with curly black hair.

Des Plaines Police responded to the 1600 Block of Howard Avenue regarding the report of a disturbance. Once on scene, the officers spoke with the victim who stated that she is a relative of the subject, Susana Perez, and they both live together. On today's date at approximately 3:00 a.m., Perez and the victim got into a verbal argument which turned physical when Perez grabbed the victim and then hit her in the face. Both parties were separated at that time and no police were called. Later that day, at approximately 3:00 p.m., the victim and Perez got into a second altercation where Perez hit the victim in the face again. This caused redness and swelling to the victim's face that was evident to officers on scene. Perez was taken into custody and transported to the Des Plaines Police station where she was subsequently arrested for one misdemeanor count of Domestic Battery. Perez was later brought to a Cook County courthouse for a detention hearing.

On January 16, 2025, Des Plaines Police responded to the 700 Block of Northwest Highway regarding the above subject, Iurii Mandryk, violating an order of protection. Once on scene, officers spoke with the victim and learned that Mandryk was served in open court with the court order in November 2024 and is in effect until February 2025. Part of the order stipulates that outside of a court ordered phone application, Mandryk is to have no contact with the victim. The victim reported receiving over one hundred emails from Mandryk between January 13 and January 16, all in violation of the order. The incident was forwarded to the Detective Bureau for a follow-up investigation. On January 11, Detectives contacted Mandryk via telephone and requested that he come into the Des Plaines Police station to speak about the incident. Mandryk stated at that time that he was out of town and was unable to. On January 24, Mandryk was taken into custody and brought to the station where he was subsequently arrested for one misdemeanor count of Violation of an Order of Protection. Mandryk was later brought to a Cook County courthouse for a detention hearing.

Des Plaines Police responded to the 600 Block of Beau Drive for the report of a disturbance between the victim and the subject, Gerardo Arredondo. When officers arrived, they spoke with the victim, who was outside, and stated that she and Arredondo had been in a relationship. On today's date, Arredondo began arguing with the victim which then escalated when Arredondo shoved the victim. The victim separated herself from Arredondo and called 9-1-1. Officers took Arredondo into custody and transported him to the Des Plaines Police station where he was subsequently arrested for one misdemeanor count of Domestic Battery. Arredondo was later brought to a Cook County courthouse for a detention hearing.
