On 01/08/2025 officers responded to the 2000 Block of Miner Street for the report of a criminal trespass to vehicle. The victim observed a subject inside of his vehicle and confronted him at which time the subject, later identified as Dominique Oliphant, left in another vehicle and the victim was able to obtain the license plate number. After a thorough investigation, the vehicle Dominique left in was discovered to have a stolen license plate and was involved with crimes with other agencies. The other agencies shared their information with this agency ultimately leading to the identification of Dominique. Officers took Dominique into custody at the Bridgeview Courthouse without incident. Officers provided Dominique with his Miranda Warnings which he stated he understood and waived them agreeing to speak with officers. Upon being questioned about the trespass
