OFFENSE: Burglary to Motor Vehicle

The victims' Freightliner truck was parked in a lot in the 600 Block of Northwest Highway during the above time frame when the Unknown Offender(s) broke the window and stole a powertrain controller. The driver's side window appeared to be smashed from an unknown object and left behind were wires hanging from the center

dashboard, where the controller was located.



CRIME REPORT

The victim came into the Des Plaines Police station to report a battery that had just occurred in the 1400 Block of Market Street. The victim stated that he and the subject, Jose Arreguin, were in the parking garage's stairwell when Arreguin asked him for a cigarette. The victim replied no when Arreguin then punched him twice in the face. Officers observed markings and bruising to the victim's left eye area consistent with being struck in that area. The officers began to search the area for Arreguin, and he was later located in the 1400 Block of Prairie Avenue in another parking garage stairwell. When asked, Arreguin admitted to striking the victim. Arreguin was taken into custody and transported to the Des Plaines Police station where he was subsequently arrested for one misdemeanor count of Battery. Arreguin was cited and released with his court information.

Des Plaines Police responded to the area of Central Road and Maryville Drive for the report of a motor vehicle accident. When the officers arrived, they attempted to speak with the drivers of both vehicles, a silver Ford Escape and a black Toyota Camry. While speaking with the victim, the officer learned that he was in the Toyota traveling east on Central Road while the Ford, driven by the subject Mykhailo Nenych, was traveling westbound. Near Maryville Drive, the Ford crossed over the center lane into oncoming traffic and struck the victim in a head on collision. The officer then spoke with Nenych who at that time was unable to provide a statement regarding the accident. Nenych's driver's license and insurance were requested by the officer and in response Nenych was using his phone and mumbling instead of producing the documents. During conversation, the officer learned that Nenych did not have his driver's license with him and admitted to drinking alcohol prior to driving when asked. The officer observed Nenych's eyes to be bloodshot, he slurred while speaking, and there was an odor of alcohol emitting from his break while he spoke. Two bottles of alcohol were also located in Nenych's vehicle on the floorboards.

Nenych was asked to perform Standardized Field Sobriety Tests, but he refused to do so. Given the physical indicators as well as the admission, the officer determined that Nenych was intoxicated. He was taken into custody and transported to the Des Plaines Police station where he was asked to provide a breath alcohol sample. Nenych refused to comply and was subsequently arrested for one misdemeanor count of Driving Under the Influence of Alcohol; ticketed for Improper Lane Usage, the Operation of an Uninsured Motor Vehicle, and Driver's License not on Person. Nenych was cited and released with his court information.

Des Plaines Police responded to Golf Road and Mount Prospect Road for a disturbance inside a black Tesla Model X on the roadway. The caller stated that the driver of the Tesla, Anil Gidwaney, was intoxicated and continued to provide location updates. As the Tesla was traveling east on Golf Road from Rand Road, the officer pulled behind it and shortly after turned on the emergency lights and conducted a traffic stop in the 1600 Block. While speaking with the driver, the officer learned that Gidwaney had consumed alcohol prior to driving. Gidwaney was asked, and consented, to perform Standardized Field Sobriety Tests. Upon completion, Gidwaney showed visible signs of impairment and was taken into custody. After being transported to the Des Plaines Police station, Gidwaney was asked to provide a breath alcohol sample, to which he agreed. The result of said sample was over twice the legal limit. Gidwaney was subsequently arrested for one misdemeanor count each of Driving Under the Influence of Alcohol and DUI with a BAC Over .08. Gidwaney was cited and released with his court information.



Des Plaines Police responded to the Rivers Casino located in the 3000 Block of S. Des Plaines River Road regarding a possible controlled substance on the floor of the casino that was later determined to belong to the subject, Munkhtur Ganzorig. Upon arriving, the officers spoke with the security manager who turned over a small white bag with a white powdery substance in it. Security advised that it was located on the third floor of the parking garage in the smoke room. The substance carried the same consistency as possible cocaine. Surveillance later showed Ganzorig in the smoking area and while holding his cellphone in his left hand, the white bag falls from his hand and onto the floor. According to live surveillance, Ganzorig was on the third floor of the parking garage walking towards a gray Honda Civic. The officers then responded to that area and located Ganzorig, took him into custody, and later transported him to the Des Plaines Police station. Once there, Ganzorig was subsequently arrested for one felony count of Possession of a Controlled Substance. Ganzorig was cited and released with his court information.



Des Plaines Police responded to the Rivers Casino located in the 3000 Block of S. Des Plaines River Road for the report of an intoxicated subject sitting in the driver's seat of a white Acura sedan in the parking lot. When the officers arrived, the Acura was seen leaving the property south on Des Plaines River Road. The officer followed and activated their overhead emergency lights in the 6300 Block of N. Des Plaines River Road in Rosemont, IL. Upon speaking with the driver, Kevin Wozniak, the officer observed he had watery eyes and a strong odor of alcohol emitting from his breath. While speaking, Wozniak was slurring his words and stated that he had not consumed any alcohol that day. The officer requested Wozniak exit the Acura, to which he complied, and while doing so lost his balance and needed the vehicle to steady himself. Wozniak was asked to perform Standardized Field Sobriety Tests, to which he agreed. Upon completion, Wozniak showed visible signs of impairment and was taken into custody. The caller later advised that they were standing near the southeast side entrance when Wozniak attempted to enter the casino but was not allowed due to him being heavily intoxicated. The witness then stated that they observed Wozniak walk to his vehicle and provided that information to Cook County Dispatch.

Wozniak was transported to the Des Plaines Police station where he was subsequently arrested for one misdemeanor count of Driving Under the Influence of Alcohol. Wozniak was cited and released with his court information.

Des Plaines Police conducted a premise check of the train station located in the 1500 Block of E. Miner Street when the officers came across multiple subjects holding the exterior door open. It should be noted that the train station was closed at that time, and no one should have been inside. As the officers approached, one of the subjects (later identified as Zachary Grzeca) attempted to leave the area to avoid police contact. Due to previous incidents, the officers knew the subject to be Grzeca and was told to stop. While speaking with the officers, Grzeca admitted that he wanted to leave because he had missed a court date and possibly had a warrant. The officer then ran Grzeca's information through the database and learned that he did have a warrant through the McHenry County Sheriff's Police Department. Cook County Dispatch confirmed with MCSPD that the warrant was valid and extraditable when Grzeca was then taken into custody and transported to the Des Plaines Police station. Once there, Grzeca was subsequently arrested for one count of the Issuance of a Warrant and later brought to a Cook County courthouse for a detention hearing.
