NOTEWORTHY INCIDENTS:

The victim and an Unknown Offender were traveling south on Graceland Avenue from Miner Street when the offender, driving a black Cadillac sedan, suddenly turned in front of the victim heading east on Ellinwood Street. The victim followed and when approaching the Cadillac at a stop, the driver/offender exited the vehicle and pointed a black handgun at the victim. The victim fled the area and called 9-1-1 reporting the offender as a tall black male wearing a flannel shirt and was last seen northbound on Lee Street.



> Des Plaines Police were on patrol in the 1400 Block of Miner Street when a black Nissan Altima was seen traveling westbound. As the Nissan was approaching the red light at Miner Street and Pearson Street, it came to a stop past the solid white line. As the officer followed the vehicle when the light turned green, the officer noted that the driver's side mirror was not on the vehicle. The officer activated his overhead emergency lights and curbed the vehicle in the 600 Block of Northwest Highway. When the officer approached the Nissan, he spoke with the driver/subject Faith Georgopoulos who appeared nervous and stated that she was driving the other subject, Kearve Williams, home who was now in the back seat. The officer informed Georgopoulos of why he pulled her over and during conversation, a second officer noted a can of alcohol in the rear cabin area of the vehicle, noting also that Georgopoulos is 19 years old and cannot legally possess or transport alcohol.

> The officer attempted to identify both the name and age of Williams; however, he was uncooperative and would not comply with any requests from the officers. At first when asked, both Williams and Georgopoulos denied the alcohol being in the car and neither were claiming it belonged to them. Williams eventually stated that it belonged to him but refused to provide any information supporting that he was legally able to possess the alcohol. While refusing to provide any identification to the officers, Williams was seen by the first officer attempting to conceal his Illinois State ID into his shoe. Williams was informed that failure to comply with the officers' requests is obstructing and upon doing

so, was ordered to step out of the vehicle. After several commands to exit the vehicle were unsuccessful, the officers escorted Williams out of the vehicle and took him into custody. Williams ID was removed from his shoe and his information was run through the database when Cook County Dispatch informed officers that he had a valid warrant through the Schaumburg Police Department. Georgopoulos was also asked to step out of the vehicle multiple times and refusing to do so and had even rolled her window up and locked the doors. Georgopoulos eventually exited the vehicle and was taken into custody.

Both Georgopoulos and Williams were transported to the Des Plaines Police station where they were charged. Williams was subsequently arrested for one misdemeanor count of Resisting or Obstructing a Peace Officer and the Issuance of a Warrant. Williams was cited and released by Des Plaines with his court information and turned over to the Schaumburg Police Department for further. Georgopoulos was subsequently arrested for one misdemeanor count of Obstructing a Peace Officer; ticketed for Disregard to a Traffic Control Device, No Mirrors, Drivers License not on Person, and the Illegal Transportation or Possession of Alcoholic Liquor by a Driver. Georgopoulos was cited and released with her court information.

Des Plaines Police responded to the Wendy's in the 1500 Block of S. Lee Street to check the well-being of a subject, later identified as Adis Ikanovic. The caller related that Ikanovic was driving a Mitsubishi Montero that had broken down at Oakton Street and Lee Street, so the caller assisted Ikanovic moving the vehicle into the parking lot. While doing so, the caller suspected that Ikanovic was intoxicated and described him as a white male with a mustache and hand tattoos. When the officers arrived on scene, they observed the Mitsubishi in the parking lot with its hazards on and unattended. A short while later, a male matching the callers description exit the restaurant and approached the officer and appeared intoxicated. Ikanovic had slurred speech, was unsteady on his feet, and was having trouble conversating with the officer. Ikanovic eventually stated that he was driving on the roadway when his car broke down and then asked for a "jump" from the officer. The officer was not able to provide that service and stated that due to Ikanovic's potential intoxication level, he takes a rideshare to his next destination. Ikanovic became uncooperative and began arguing with officers and placing himself near them. Ikanovic was told to stay away from and moved several times away from the officers. Ikanovic stated that he had a second party inside the vehicle who was inside the restaurant when the officers went to check to see if they would be able to drive. While inside the restaurant, Ikanovic came in a short while later stating that he has a "FOID", known to officers as a Firearm Owners Identification Card, that he can carry a firearm

and "blast" them. At that time, Ikanovic raised both of his hands with his right hand making a motion towards the officer implying he would shoot them. Ikanovic was taken into custody and transported to the Des Plaines Police station where he was subsequently arrested for one misdemeanor count of Aggravated Assault. Ikanovic was cited and released with his court information.



Des Plaines Police responded to the 1200 Block of E. Touhy Avenue for a disturbance where a third party caller reported that there was an incident at that location. When the officers arrived, they spoke with a female and male at the door, the male later identified as the above Lance Harris. The female was asked to step into the hallway to speak to officers, which she complied with, while Harris shut the door. During conversation, it was learned that there was an argument that occurred between the female and Harris. While officers were speaking Harris would open the door and yell obscenities towards the female and the officers. Harris then threatened physical harm to the female if she were to enter the room. At one point, Harris exited the room and quickly approached one of the officers with clenched fists and took a fighting stance. In response, the officer placed his left hand out in a motion for Harris to stop and create distance when Harris then struck the officer's hand. Due to his increasing aggression and the battery, the officers took Harris into custody and transported him to the Des Plaines Police station. Once there, Harris refused to speak with the officers about the incident and the Cook County State's Attorney's Office was contacted. After speaking with them, a felony charge was approved. Harris was subsequently arrested for one felony count of Aggravated Battery to a Peace Officer. Harris was later brought to a Cook County courthouse for a detention hearing.
