While speaking with Juan, the officer detected the odor of fresh cannabis emitting from inside the vehicle and also observed small green leafy substance suspected to be cannabis on Juan's shirt. Juan admitted to having a container of cannabis in the center console area. A search of Juan's information showed his driver's license was suspended. The license plate on the vehicle was also found to be fictitious. The officer searched the



On 01/25/2025 Des Plaines officers responded to the 700 block of Wolf Road for the report of a Violation of an Order of Protection. The victim relayed she has an order of protection against subject, Edgar Hernandez, who is not to have any contact with her. On the above date and time, the victim was in a parking lot when Edgar ran up to her to speak with her. She is unaware how Edgar knew where she was and he left the scene prior to officer's arrival. Officers spoke with Edgar over the phone who admitted to violating the order. He was asked to come to the station and Edgar relayed he would call the officer back. The officer attempted to contact Edgar several times and was met with no answer. After a thorough investigation, officers made contact with Edgar who agreed to turn himself in to the station on 02/13/2025. The Cook County State's Attorney's Office was contacted who approved one felony count of Stalking and one misdemeanor count of Violation of an Order of Protection He was transported to court for a detention hearing.
