Officers were on patrol near the 500 block of Northwest Highway when they observed a running vehicle parked on the sidewalk. Upon closer inspection, officers reported that the vehicle had struck a landscaping stone which had damaged the vehicle. Officers reported that a female later identified as Natalie Simmons sleeping in the driver's seat. Officers attempted to wake Simmons noting that the driver's window was partially rolled down. Officers observed open alcohol in the cup holder and smelled a strong odor of alcohol emitting from the open window. Once Simmons awoke, officers observed that she was disoriented, and had bloodshot watery eyes. Officers attempted to get her to shut off the vehicle, however she attempted to go back to sleep. Eventually officers were able to unlock the door and turn off the vehicle. Simmons was unaware of her location in Des Plaines and had difficulty remembering recent events but was able to provide that she was in Schiller Park, that she was at Sway Bar, and that she had a couple drinks. While communicating with her Officers reported that Simmons had slurred speech

Simmons refused to perform standardized field sobriety testing. As such, Simmons was taken into custody on suspicion of driving under the influence of alcohol. At the station, Simmons refused to provide an adequate breath sample. Simmons then stated that she did not wish to speak with officers any further without a lawyer present.

Natalie was charged with DUI- Alcohol, driving on the sidewalk, Illegal Transportation or Possession of Alcoholic Liquor by Driver in Motor Vehicle, Operation of Uninsured Motor Vehicle and given a court date and released.



Officers responded to the 1800 block of Morse Avenue in reference to a domestic battery. Upon their arrival they spoke with the victim who reported that she and suspect Jason DeCook were living

together and having relationship trouble. The victim reported that DeCook wanted her to leave the residence, and she was concerned that she would not be let back inside. DeCook became more aggressive and eventually slapped her forcefully across the face causing her to bleed from the mouth. The victim reported that DeCook then took her to the ground and began to strangle her by the neck restricting her breathing. DeCook then let her go and left the residence. She then contacted 911.

Officers spoke with DeCook after reading his Miranda Warning. DeCook denied striking and choking the victim. DeCook related that the victim became angry because he was listening to loud music and began packing up her belongings. DeCook related that she left the residence. He denied the allegations and stated that the victim had mental health issues, and her injuries were self-inflicted.

Due to the physical evidence observed on the victim as well as observing scratches on Decook's arms which were consistent with the victim attempting to defend herself, DeCook was placed under arrest and taken into custody. He was charged with Domestic Battery and prepared for bond hearing.

Officers responded to the area of Lee Street between Oakwood Avenue and Thacker Street for a report of a traffic crash. Officers located a struck parked vehicle at 1062 Lee Street and located the other vehicle, a black Mazda was also unoccupied in the middle of the road. Officers were able to find a driver's license inside the vehicle belonging to Jigesh Patel. Officers searched the area and located him walking near Prairie and Lee Street. Patel stated that he was the driver of the Mazda and related that the other vehicle had stopped in front of him. Officers related to him that the other vehicle had been parked and was not moving. Patel started answering questions about his recent whereabouts when officers noted that his speech was slurred, had difficulty keeping his balance, and he had bloodshot watery eyes.

Patel agreed to perform standardized field sobriety testing. Officers started conducting the Horizontal Gaze Nystagmus test and 6 clues were observed.) Patel then refused to complete the rest of the SFST's and Patel was placed under arrest on suspicion of DUI and transported to the station. While at the station and being admitted to lockup Patel became aggressive and struck and the officer in the face.

Patel was charged with DUI - Under the Influence of Alcohol, Aggravated Battery - Peace Officer, Possession Adult Use Cannabis In Passenger Area of Motor Vehicle – Driver, Operation of Uninsured, Failure to Remain at the Scene of a Vehicle Damage Accident Motor Vehicle, Improper parking on the roadway, Failure to reduce speed, Improper Lane Usage.

While on patrol officers conducted a "high risk" traffic stop on a stolen Toyota which was near River Road and Rand Road. Officers spoke with the driver, Rehman Imtiaz-Abdur who related that he was renting the vehicle from a private party. He provided officers with a text thread proving it was a rental. Officers looked at the text threat which showed Rehman Imtiaz-Abdur was renting the vehicle for \$160 per week but had not returned it after being asked to return it several times by the owner. Rehman Imtiaz-Abdur related that the vehicle needed to be fixed and he had to spend money to get the work done which is why he won't return the vehicle until he gets paid.

Rehman Imtiaz-Abdur was taken into custody and taken to the police department for further investigation. After speaking with the victim and the Cook County States Attorney, Rehman Imtiaz-Abdur was charged with possession of a stolen vehicle and sent to Skokie for Bond Hearing.
