Officers responded to the area of 3000 s River Road in reference to an unwanted subject. Upon their arrival, officers spoke with security who explained that subject Alejandro Mejia-Lopez was no longer welcome on the property, and they wanted him to leave. They further explained that they would sign a trespass complaint if he refused to leave. Officers spoke with Aljandro and asked him to leave explaining that he would be arrested for trespassing if he refused. He ignored the officers' repeated attempts to convince him to leave the property. Officers moved to arrest Alejandro at which point he locked his arms and dropped his weight to the ground to resist being handcuffed. Once he was in custody officers learned he had an active warrant out of Iroquois County.

Alejandro was transported to the police station where he was charged with Criminal Trespass, Resisting or Obstructing Peace Officer (2 Counts), and processed on the warrant.
