LOCATION: 3000 Block of S. Des Plaines River Road



Des Plaines Police responded to the 0-100 Block of W. Golf Road for the report of a motor vehicle accident. When the officers arrived on scene and spoke with all parties it was learned that the subject, Daniel Roy, was driving a Honda civic and along with two other vehicles, were eastbound on Golf Road. In the 0-100 Block, the first two vehicles slowed for traffic while Roy failed to reduce speed and struck the rear bumper of the vehicle in front of him which then propelled that vehicle into the rear bumper of the third vehicle. Roy related that he had been distracted while driving which caused the accident. In response to the officers' questions Roy was short and appeared confused. The officer smelled a strong odor of alcohol emitting from his breath and observed Roy's eyes to be watery/bloodshot. Roy's drivers license and proof of insurance was requested by the officers when Roy handed them his license but was unable to locate an insurance card. When asked again regarding the insurance card, Roy stated to officers that he had already given it to them. The officers suspected that Roy was intoxicated and asked him if he had anything to drink prior to drinking to which Roy did not respond. Roy was also asked to perform Standardized Field Sobriety Tests, which again he refused to respond to.

Roy was taken into custody and transported to the Des Plaines Police station and a search of his vehicle was conducted yielding multiple bottles of alcohol. Once at the station, Roy was also asked to provide a breath alcohol sample which he refused. Roy was subsequently arrested for one misdemeanor count of Driving Under the Influence of Alcohol; ticketed for Failure to Reduce Speed to Avoid an Accident, the Operation of an Uninsured Motor Vehicle, and the Illegal Transportation or Possession of Alcoholic Liquor by a Driver. Roy was cited and released with his court information.

# CRIME REPORT

On March 4, 2025, at approximately 12:00 p.m. Des Plaines Police were dispatched to the Des Plaines Public Library in the 1500 Block of Ellinwood Street for the report of unwanted subjects in the area. When the officers arrived, they spoke with the complainant who stated that three subjects were seen drinking alcohol in the front breezeway inside the library and that the subjects have since left. The officers were contacted a second time at approximately 2:40 p.m. regarding the same subjects and stated that they were in the same location consuming alcohol. As the officers arrived on the scene for the second time, the subjects were seen inside the library breezeway sitting at a table with an open bottle of alcohol clearly visible through a plastic grocery bag. The officer made contact with the subjects and identified one of them as the above, Christopher Scott. All subjects were advised that the employees no longer wanted them on the property. Two of the subjects complied and left the area while Scott became aggressive and refused to leave. The officer removed the bottle of alcohol from the table and Scott demanded that he give the bottle back. Scott was advised that he was in violation of a city code and the bottle was being confiscated. Scott refused to provide identification when requested and also refused to leave the property. At one point, Scott stood up and tried to grab the bottle of alcohol from the table and when the officer stopped him and attempted to take him into custody, Scott started to resist by pulling his arms away from the officers. Once in handcuffs, Scott was escorted to a squad car and seated in the back seat. Once there, Scott used his right leg and kicked the officer in the

Scott was transported to the Des Plaines Police station where he was subsequently arrested for one felony charge of Aggravated Battery to a Peace Officer, one misdemeanor charge each of Resisting a Peace Officer and Criminal Trespass to Real Property; cited for Des Plaines City Ordinance Open Alcohol in Public. Scott was later brought to a Cook County courthouse for a detention hearing.
