Des Plaines officers responded to the 300 block of Third Avenue for the report of a domestic incident. Officers arrived on scene and observed a subject, later identified as Leonard Vargas, exiting the building. Officers spoke with the victim who relayed she and Leonard were hanging out and they got into a verbal argument at which time she stated she was going to call 9-1-1. Leonard told her not to, grabbed both of her arms and took the phone from her. The victim had minor injuries to her arm and chest. Leonard eventually gave her phone back and she called 9-1-1. A search showed an active Order of Protection again Leonard as well. He was taken into custody and transported to the station. He was subsequently charged with Domestic Battery, Violation of an Order of Protection and Interference with Reporting of Domestic Violence. He was transported to court for a detention hearing.

A search of the vehicle revealed approximately twelve grams of cannabis in the trunk which was recovered. Officers searched Saul and recovered a plastic bag with a brown plantlike substance, suspect Psilocybin, in his pocket. Saul was subsequently charged with Possession of Controlled Substance, Possession of Adult Use Cannabis in Motor Vehicle and Revoked Driver's License. He was also cited for No Rear Registration Light and Operation of Uninsured Motor Vehicle. He was cited and released with his court information.
