Officers were on patrol in the area of River and Rand Road when they observed a gray sedan stopped in the intersection slumped over the wheel. After further investigation officers were able to wake the driver, identified as Christopher Von Wolter who appeared to be intoxicated. Once he woke, Von Wolter immediately fled the scene despite the overhead emergency lights being activated. Officers were eventually able to get Von Wolter to stop the vehicle on the side of the road.

Officers then had a conversation with Von Wolter who related that he was just trying to get home. Von Wolter related that he thought he was in the city (of Chicago). Von Wolter further related he was stopped in the middle of road because he was trying to stay off the roadway until he felt comfortable driving. Officers reported that they could smell an odor of alcohol and observed his eyes to be bloodshot and watery. While speaking with officers, Von Wolter was slurring his speech.

Von Wolter consented to standardized field sobriety tests. The one leg stand and walk and turn tests were conducted. Officer reported that Von Wolter performed poorly. At that time, Von Wolter was arrested on suspicion of DUI and taken into custody without incident.

After being transported to the police station Von Wolter consented to a breathalyzer test which was conducted. The test results indicated Von Wolter BAC was 0.178.

Von Wolter was charged with DUI- Alcohol, DUI- Blood alcohol concentration or breath .08 or more, Improper parking on roadway, and driving an uninsured motor vehicle. He was given a court date and released on bond.
