NOTEWORTHY INCIDENTS:

OFFENSE: Hit and Run Accident

A 68-year-old male Mount Prospect resident/the victim and Unknown Offender were traveling southwest on Golf Road passing the intersection with Wolf Road in the inside lane. Just west of the intersection, the victim had stopped for traffic when the offender failed to reduce speed and struck the victim in the rear bumper. After the accident, the offender fled in a black sedan west on Golf Road without exchanging information.

Due to the recent increase in crime happening at the YMCA building located at 300 E. Northwest Highway, the following are reported incidents at that location:

On February 25, 2025, Des Plaines Police responded to a business in the 2100 Block of Frontage Road for the report of a theft. Once there, the officer spoke to the victim, a 65-year-old male Kildeer resident, who stated that he owns the business, Design Group, located in that block. The victim stated that during the month of January and February

he noticed approximately \$4,000.00 worth of power tools was stolen from the warehouse at that location. At that time, there was no known information about who committed the theft, and the report was turned over to the Detective Bureau for investigation.

Upon follow up, Detectives learned that the subject, Reno Saccaro, had been involved in the incident and was a current employee of the company. On March 13, 2025, Detectives returned to the 2100 Block of Frontage Road where they met with Saccaro and took him into custody. After being transported back to the Des Plaines Police station, Saccaro was given his Miranda Rights which he waived and made a statement admitting to stealing the power tools.

The Cook County State's Attorney's Office was contacted who then approved felony charges. Saccaro was subsequently arrested for one felony count of Theft Over \$500.00. He was cited and released with his court information.
