NOTEWORTHY INCIDENTS:

OFFENSE: Burglary to Motor Vehicle **DATE/TIME:** 04/05/2025 – 04/07/2025

LOCATION: 2300 Block of S. Mount Prospect Road

REPORT #: 25-01762

The victim, Sunrun Solar, located in the 2300 Block of S. Mount Prospect Road reported that fourteen of their work vehicles were broken into over the above time frame and out of them were stolen spools of copper wire and power tools. All the vehicles were parked in the lot during the time of the incident and each vehicle had a window shattered giving the Unknown Offender(s) access to them. The vehicles ranged from Ford Transit vans to Dodge Ram Promaster 3500's.

OFFENSE: Burglary to Motor Vehicle

The 37-year-old male Des Plaines resident/victim had parked his Dodge Ram pick-up truck on the roadway in the 1600 Block of Lunt Avenue during the above time frame when the Unknown Offender(s) broke into the vehicle. The officer observed the rear driver's side window was shattered and the glove box was open, indicating that the offender(s) entered the vehicle with the intent to burgle it.



Des Plaines Police responded to the Comfort Inn Hotel located in the 2100 Block of E. Touhy Avenue regarding the report that the Unknown Offender(s) broke into approximately ten vehicles in the parking lot during the above time frame. Once on scene, the officer observed the vehicles to be located on the west side of the parking lot and appeared to have had a window broken out allowing the Offender(s) into the

vehicles. Multiple compartments were left open inside vehicles but as of this report, nothing appeared to be stolen.

The Unknown Offender(s) entered an apartment building elevator located in the 700 Block of S. Des Plaines River Road and wrote on the west side elevator wall. The writing was described as with a black marker and was similar to previous incident that occurred recently.

The victim, 7-Eleven, located in the 800 Block of W. Oakton Street reported that a customer entered the store on April 2, 2025, at approximately 7:42 p.m. and stole two gift cards worth \$100.00 USC each. The store employee related that the Unknown Offender had originally approached the cashier with three gift cards and provided the employee with two \$100.00 USC bills. The employee advised that he needed payment for the third gift card when the offender then returned the gift card to the shelf intending to only purchase two. After the cashier loaded the gift cards with the appropriate amount, he provided the offender with the receipt and had mistakenly given the \$200.00 USC back. The offender then left the store but returned two days later when he was notified that he needed to provide payment but refused. The offender is listed as a Hispanic male subject of medium build.

OFFENSE: Criminal Damage to Property

In June of 2023 the Des Plaines Police Department responded to the Comfort Inn Hotel located in the 2100 Block of E. Touhy Avenue regarding the report of a burglary. Once there, the officer spoke with the complainant who stated that they rented a Jeep Grand Cherokee from Avis Car Rental and had parked it in the hotel parking lot at approximately 8:30 p.m. on June 24, 2023, on the east side of the parking lot. When the complainant returned to the Jeep the following morning, they discovered that all four tires were punctured/flat, the dash media display screen was cracked, there were cigarette burn marks in the front passenger seat, the rear passenger seat had been cut. Additionally, there was a beer bottle located on the rear passenger seat that the complainant advised was not his. There did not appear to be signs of forced entry to the vehicle so it is unknown if the doors were locked at the time of the incident. All items of evidentiary value were recovered by an Evidence Technician and the case was turned over to the Investigations Division for follow-up.

On June 28, 2023, Detectives went to speak with the manager of the hotel regarding surveillance footage of the incident and spoke with the manager. The manager related that after reviewing the footage, she could identify the subject who entered the Jeep as the above, Luis Gonzalez-Luna, due to him frequenting the business. The manager also advised that Gonzalez-Luna had been a registered guest of the hotel on the night of the incident. The Detective then reviewed and recovered the surveillance footage which shows the male subject identified as Gonzalez-Luna approach the Jeep on four separate occasions between 12:58 a.m. and 3:57 a.m. the night of the incident. Gonzalez-Luna is seen opening the back hatch and walking around it multiple times. Detectives attempted multiple times over the course of the investigation to contact Gonzalez-Luna but were met with negative results.

Due to the subject being positively identified in the video footage, Detectives contacted the Cook County State's Attorney's Office requesting and later approving felony charges. An arrest warrant for Gonzalez-Luna was obtained on March 22, 2024. On April 6, 2025, DPPD received notification that the Chicago Police Department had Gonzalez-Luna in custody. Des Plaines officers traveled to the CPD District 16 and met with CPD who then turned Gonzalez-Luna over to them. Gonzalez-Luna was then transported to the Des Plaines Police Station for further investigation. Gonzalez-Luna was given his Miranda Rights which he waived and agreed to speak with Detectives where he admitted to being inside the car and causing damage.

Gonzalez-Luna was subsequently arrested for one felony count of Burglary and one count of the Issuance of a Warrant. He was later brought to a Cook County courthouse for a detention hearing.

OFFENSE: Possession of a Controlled Substance / Traffic

Des Plaines police were on patrol traveling west on Oakton Street near Lee Street when the officers observed a gray Subaru Legacy on the roadway with what appeared to be expired state registration. The officers ran the license plate through the database and confirmed that the state registration was in fact expired before activating her overhead emergency lights and curbing the vehicle in the 800 Block of W. Oakton Street. As the officer approached the driver, later identified as Jack Albrecht, it was noted that he was the sole occupant of the Subaru at the time of the stop. Albrecht was asked for his driver's license and proof of insurance while being informed for the reason of the citation. While the items were being retrieved, the officer observed a beer bottle cap on the floorboard directly below the steering wheel. Albrecht appeared nervous and was visibly shaking while interacting with the officers. The officer then asked Albrecht if he had consumed anything to drink before driving which he admitted he had and then confirmed the beer bottle cap on the floorboard. Albrecht was asked to exit the vehicle to perform Standardized Field Sobriety Tests, which he agreed and while exiting the open but empty beer bottle was observed in the driver's door. A brief search of Albrecht's person was conducted when officers observed an item in his right pocket consistent with a small plastic bag commonly known to the use of narcotics. Without removing the item, the officers asked Albrecht about the bag when he removed it from his pants and turned it over to the officers. The officer then noted that inside the bag was a white powdery substance, suspected of being cocaine.

The officer conducted the SFST's to determine if Albrecht was intoxicated to which he did not show signs of impairment. Albrecht was placed into custody and then



transported to the Des Plaines Police Station along with the small bag recovered. Once there, the officer used a Narcotics Identification Kit on the white powdery substance which was positive for the probable presence of cocaine. Albrecht was subsequently arrested for one felony count of Possession of a Controlled Substance and ticketed for Expired Registration. He was cited and released with his court information.

OFFENSE: Driving Under the Influence of Drugs or a Combination of Drugs / Traffic



Des Plaines Police responded to the area of Golf Road and East River Road for the report of a motor vehicle accident. Once on scene, the officer observed a female in the Toyota asleep behind the wheel of the vehicle. It was later determined that a white Toyota Camry and an orange Chevrolet wagon were both eastbound on Golf Road approaching East River Road. The Chevrolet stopped due to the traffic light being red when the Toyota, being driven by the above subject, Brooke Vicks, failed to reduce speed and rear ended the Chevrolet. The officer woke Vicks up who then appeared highly confused and spoke thick tongue/slurred her speech. Vicks admitted to rear ending the car in front of her and stated she was tired and that is why she was sleeping. Multiple medication bottles were observed in a backpack in the passenger seat. The officer requested that Vicks exit the vehicle, to which she complied and then gave the officer permission to search the vehicle. Upon doing so, the officer observed that the medication bottles were not labeled, and he was unable to determine if Vicks was prescribed those medications. Inside an Altoid tin was located multiple different color tablets, some of which we partially crushed. When asked, Vicks admitted to taking four tablets of "Norco" which is a controlled substance containing hydrocodone. The officer

requested that Vicks perform Standardized Field Sobriety Tests, to which she agreed and upon completion showed visible signs of impairment. Vicks was taken into custody and later transported to the Des Plaines Police station along with the recovered items. At the station, the officer used a Narcotics Identification Kit to identify the tablets found in the Altoids tin which tested positive for the probable presence of Amphetamines. All pills and tablets found will be submitted to the Illinois State Police Crime Lab for further testing. Vicks was subsequently arrested for one misdemeanor count of Driving Under the Influence of Drugs or a Combination of Drugs and ticketed for Failure to Reduce Speed to Avoid an Accident. She was cited and released with her court information.

Des Plaines Police were conducting a premise check of the parking garage in the 1400 Block of Prairie Avenue when four subjects were observed with a bottle of liquor in the northeast stairwell. The subjects were told to leave the property, and the liquor was disposed of. While doing so, a female subject, later identified as Bridget Maguire, began to yell at the officers and refused to leave the property. Maguire was uncooperative with officers and then kicked at the officer causing her to believe that Maguire was attempting to batter her. The officers then attempted to place Maguire into custody when she began to tense her arms and pull away from them. Maguire continued to refuse to place her hands behind her back but was ultimately handcuffed and then transported to the Des Plaines Police Station. Once there, Maguire was subsequently arrested for one misdemeanor count each of Aggravated Assault and Resisting a Peace Officer. Maguire was cited and released with her court information.
