NOTEWORTHY INCIDENTS:

OFFENSE: Theft

DATE/TIME: 04/06/2025 1:30 p.m. – 1:45 p.m.

LOCATION: 3000 Block of S. Des Plaines River Road

REPORT #: 25-01870

The victim, a 57-year-old female Schiller Park resident, was inside the Rivers Casino located in the 3000 Block of S. Des Plaines River Road playing the slot machines during the above time frame. The victim got up and briefly walked away from the machine without cashing out the balance of approximately \$42.00 when the Unknown Offender removed the voucher from the machine and fled the property. Surveillance and a witness to the incident described the offender as an older Hispanic male.

The victim, a 67-year-old female Des Plaines resident, met the Unknown Offender online and began a friendship with her over the above time frame. During that time, the offender posed as a medical sales representative and would ask the victim to send her money. In total, there were six transactions and approximately \$48,000.00 that was transferred either via wire transfer or money order. The offender identified themselves as a female living in Iowa, but communication was solely through "Whatsapp" via text or calls.

The victim's, a 38-year-old female Des Plaines resident, son was sitting at an outside table in the 500 Block of E. Oakton Street and when he left, he forgot his backpack. When the victim returned to the area to retrieve the bag, she discovered that the Unknown Offender(s) had stolen the bag. The victim started pinging a cellphone that

Des Plaines Police responded to the 400 Block of Edward Court for the report of a battery that had occurred. When the officers arrived, they were approached by the male subject, later identified as the above John Largent, who was in the street and stated that he may have hit someone. The officers were able to locate the victim, a 31-year-old Des Plaines resident, who stated that he lives in the area and Largent was harassing workers that were building a fence on the victim's property. Largent approached the victim yelling at him, pushed him in the chest, and then walked away. Largent was seen walking up and down the street before approaching the victim a second time and again shoving him. Video footage of the incident was reviewed that was consistent with the victim's account of the incident. Largent was taken into custody, transported to the Des Plaines Police station where he was subsequently arrested for one misdemeanor count of Battery. Largent was cited and released with his court information.


OFFENSE: Issuance of a Warrant

Des Plaines Police were on patrol when a silver Chevrolet SUV was seen running and occupied in front of the liquor store in the 600 Block of S. Wolf Road. The officer parked his vehicle and approached the SUV and spoke with the single occupant, later identified as Barry Morris. Morris had acknowledged that he had been sitting in the parking lot for a longer period of time because he was sleeping and provided the officer with his driver's license voluntarily. The officer ran Morris' information through the database which alerted officers that there was a warrant for Morris out of the Cook

County Sheriff's Police Department. Cook County Dispatch confirmed the warrant was valid and extraditable when Morris was informed of the violation. Morris was asked to step out of the vehicle, which he complied with, and was taken into custody. The officer transported Morris to the Des Plaines Police station where he was subsequently arrested for one count of the Issuance of a Warrant. Morris was later brought to a Cook County courthouse for a detention hearing.

Des Plaines Police responded to the bus stop near Pearson Street and Miner Street for the report of three subjects who were about to fight. When the officers arrived, they spoke with one of the parties who stated that his friend, Joseph Chol, was intoxicated but they were not going to fight. While speaking with the other party, Chol approached one of the officers with his hands clenched in a fist leading the officer to believe Chol was attempting to hit him. One of the officers pushed Chol back to prevent the battery but Chol then got very close to the officer, placing his hand in the officer's face and threatened to kill him. Chol was taken into custody and transported to the Des Plaines Police Station. In holding, the officers were attempting to conduct a search of Chol's person when he started pulling away. Two officers had to hold Chol while they assisted in the searching of his person. Chol was subsequently arrested for one misdemeanor count each of Aggravated Assault and Resisting a Peace Officer. Chol was cited and released with his court information.



Des Plaines Police responded to the 800 Block of E. Oakton Street for the report of a single vehicle crash involving a white Ford F150 that struck one of the perimeter fences around the property. It was learned that while traveling north in the parking lot, the Ford lost control and drove into the fence. The above subject, Ezequiel Pulido, was seen standing outside of the Ford and had admitted to losing control crashing into the fence. While speaking with Pulido, the officer observed he had watery/bloodshot eyes and there was a strong odor of alcohol emitting from his breath. The officer asked if he had

consumed alcohol prior to driving, which he stated he did. Pulido was asked to perform Standardized Field Sobriety Tests, to which he agreed, and upon completion showed visible signs of impairment. Pulido was taken into custody and transported to the Des Plaines Police station where he was also asked to provide a breath alcohol sample. Pulido refused to provide a sample and refused to make any further statements regarding the incident. Pulido was subsequently arrested for one misdemeanor count of Driving Under the Influence of Alcohol. He was cited and released with his court information.

Des Plaines Police were on an unrelated traffic stop when a black-in-color vehicle was seen jerking forward, screeching its tires, and revving its engine in the 800 Block of S. Des Plaines River Road while stopped at the red light with Miner Street. The vehicle was identified as a black Dodge Challenger and once the traffic light turned green, the Dodge revved the engine and screeched the tires while completing a left turn from Des Plaines River Road onto Miner Street. The officer concluded the current traffic stop and pulled behind the Dodge, activating the overhead emergency lights. As the officer approached the driver's side of the vehicle, she spoke with the driver/subject, Zackary Campbell. Campbell had a freshly lit cigarette in his mouth, his eyes were watery/bloodshot and he was slurring his speech. The officer requested Campbell's driver's license and proof of insurance. In response, Campbell provided the officer with a Florida driver's license and a receipt for an oil change. Campbell then continued to look for his driver's license and when asked about the receipt, he stated it was his vehicle registration.

The officer asked Campbell where he was going when he stated he was going home and that he didn't do anything wrong/commit any traffic violations before apologizing multiple times. Campbell denied consuming alcohol when asked by the officer, however, it was still suspected that he was intoxicated. The officer asked Campbell to perform Standardized Field Sobriety Tests, to which he agreed. Upon completion, Campbell showed visible signs of impairment, was taken into custody, and transported to the Des Plaines Police station. Once there, Campbell was also asked to provide a breath alcohol sample, the result of which was over two times the legal limit. Campbell was subsequently arrested for one misdemeanor count each of Driving Under the Influence of Alcohol and DUI with a BAC Over .08; ticketed for Squealing or Screeching Tires. Campbell was cited and released with his court information.
