### NOTEWORTHY INCIDENTS:

The victim, a 62-year-old female Des Plaines resident, reported that she was made aware of an issue with her banking information and upon looking into it, discovered that the Unknown Offender(s) had rerouted her direct deposit from Social Security to a financial institution in Naperville, IL. Social Security Services advised that the request for a new deposit account was made in April of 2024. Over the course of the last year, the deposited amount into the offender(s) account was approximately \$4,100.00. Upon contacting the bank, they were not able to release the name on the account.

Des Plaines Police were on patrol when a blue Subaru WRX was seen on the roadway on Wolf Road traveling at a high rate of speed. The officer observed the speed on the vehicle to be 71 MPH in a marked 35 MPH speed zone. After pulling onto the roadway and behind the Subaru, the officer activated his overhead emergency lights and conducted a traffic stop. Upon speaking with the driver, Marc Averilla, the officer informed him for the reason of the stop and also requested his driver's license and proof of insurance. Averilla was unable to provide the requested documents but gave the officer his information. The officer then ran the information through the database and was alerted that Averilla did not have a valid driver's license, said license was suspended by the Illinois Secretary of State. It was also discovered that the Illinois state registration for the Subaru was expired. Averilla was advised of the violation, asked to step out of the vehicle, and was taken into custody. After being transported to the Des Plaines Police station, Averilla was subsequently arrested for one misdemeanor count each of Speeding Over the Posted Speed Limit 31 – 40 MPH Over and Driving on a Suspended Driver's License; ticketed for Expired Registration and the Operation of an Uninsured Motor Vehicle. Averilla was cited and released with his court information.
