NOTEWORTHY INCIDENTS:

OFFENSE: Burglary to Motor Vehicle

The victim, Sunrun Solar, parked their Dodge Ram pick-up truck on the south side of a parking lot in the 2300 Block of S. Mount Prospect Road overnight when the Unknown Offender(s) entered the vehicle and stole multiple spools of copper wiring. The Dodge had damage to the front windshield, the front passenger side vent window, and the wood portion separating the cabin from the cargo area. It appears that the offender(s) damaged the lock on the passenger side sliding door to gain entry.

On April 3, 2025, Des Plaines Police responded to the 1300 Block of S. Mount Prospect Road for the report of a subject, later identified as Angel Gomez Jr., damaging property. As officers were responding, Cook County Dispatch informed them that Gomez had smashed the window of the business/victim, Ceva Logistics. When the officers arrived, they spoke with the caller who advised they had seen a shattered small window on the building and had video surveillance of the incident. The officer and callers both watched the footage that showed a grey GMC pick-up on the south side of the building parked near the damaged window. A male subject/Gomez was seen with a light-colored top exiting the driver's seat, approaching the door/window and attempting to enter the building. Due to the door being locked, he was unable and returned to the car to grab a baseball bat. Gomez is then seen hitting the window with the bat causing it to shatter. Through investigation, the subject was identified as Gomez in the video, but multiple attempts were made to contact him, all with negative results.

The investigation was turned over to the Detective Bureau for follow-up. On April 14 and 15, Detectives were able to reach Gomez and arrange for him to come into the Des Plaines Police station to talk about the incident. On April 16, Gomez came into the station and was escorted to a secure area of the building. Once there, Gomez was given his Miranda Rights, which he waived and agreed to speak with officers. During his statement, Gomez admitted to causing damage to the window. Gomez was subsequently arrested for one misdemeanor count of Criminal Damage to Property. He was cited and released with his court information.

Des Plaines Police were on patrol when a black Acura sedan was seen on the roadway traveling with only one headlight in the 2100 Block of S. Lee Street. The officer pulled behind the vehicle, activated his overhead emergency lights, and curbed the Acura. Upon approach of the driver's side, the officer made contact with the sole occupant and driver, Michael Singhaseni, and informed him the reason for the traffic stop. The officer requested his driver's license and proof of insurance, which he was unable to produce. Singhaseni provided the officer with his information which was then run through the database alerting the officer that Singhaseni had a warrant through the Cook County Sheriff's Police Department. Cook County Dispatch confirmed the warrant was valid and extraditable when Singhaseni was advised of the violation and asked to step out of the vehicle. Singhaseni complied and upon doing so, was taken into custody. After being transported to the Des Plaines Police station, Singhaseni was subsequently arrested for one count of the Issuance of a Warrant and later brought to a Cook County courthouse for a detention hearing.

Des Plaines Police responded to the Extended Stay in the 1200 Block for the report of a male subject who was a guest at the hotel staying in room #231 harassing another guest. When the officers arrived, they spoke with hotel staff who stated the 17-year-old female victim who stated that while standing in the hallway, a male subject, later identified as Keith Lang, approached her and started making alarming comments. The victim stated that she was afraid and re-entered her room and then they contacted the front desk to report the incident. The front desk provided a photocopy of the driver's license for the guest staying in room #231 which came back to Lang. Lang's information was run through the database using Cook County Dispatch who advised there was an active warrant for him out of the Cook County Sheriff's Police Department. The officers then went to Lang's room and knocked on the door. Lang came to the door when the officers informed him that he had a warrant for his arrest and stepped inside. When the officers attempted to handcuff Lang, he pulled his right arm away from the officers. Eventually,

Lang was handcuffed and escorted to a patrol vehicle then transported to the Des Plaines Police station. Once there, Lang was subsequently arrested for one misdemeanor count each of Disorderly Conduct, Resisting a Peace Officer, and the Issuance of a Warrant. He was later brought to a Cook County courthouse for a detention hearing.

Des Plaines Police responded to a disturbance in the 1300 Block of Briar Court for the report of a violation of an order of protection. Cook County Dispatch informed that the subject, Brian Holovaty, was reportedly at the property and fighting with the victim, 61-year-old male Des Plaines resident. Holovaty had already been served with the order of protection stipulating he is not to be on the property or near the petitioner. When the officers arrived, they observed Holovaty on the corner of the property holding a large piece of wood. The officer immediately gave commands to Holovaty to drop it and place his hands around his back, which he complied with and was handcuffed without further incident. The officers then spoke with the victim and witnesses who stated that Holovaty came onto the property and broke a lock and door to the unattached garage. When confronted by the victim, Holovaty threatened to strike him with a skateboard before then walking away. Holovaty, who was seated in a patrol vehicle, was then transported to the Des Plaines Police station where he was subsequently arrested for one misdemeanor count each of Violation of an Order of Protection, Criminal Damage to Property, and Aggravated Assault. Holovaty was later transported to a Cook County courthouse for a detention hearing.

Des Plaines Police responded to the 1800 Block of White Street for the report of a motor vehicle accident. Cook County Dispatch informed the responding officers that one vehicle had crashed into multiple parked vehicles in that area. When the officer arrived, they spoke with the passenger of a blue Nissan Altima who stated that her friend/subject, Isabel Resendis Corona, was driving the vehicle at the time of the crash. The officer noted that the blue Nissan was traveling on the roadway and struck a silver Toyota Rav-

4 parked and unattended. When the accident happened, a witness looked outside and saw a female subject, Resendis Corona, in the driver's seat and identified her on scene. The officer then spoke with Resendis Corona when he noted she had watery/bloodshot eyes and was emitting a strong odor of alcohol. In order to steady her balance, Resendis Corona was leaning on a tree nearby and refused to provide identification. Resendis Corona admitted to driving the vehicle and that she had consumed alcohol prior to driving. The officer asked Resendis Corona to perform Standardized Field Sobriety Tests, to which she agreed and upon completion showed visible signs of impairment. Resendis Corona was taken into custody and transported to the Des Plaines Police station where she was asked to provide a breath alcohol sample. Resendis Corona agreed and submitted a reading of twice the legal limit. Resendis Corona was subsequently arrested for one misdemeanor count each of Driving Under the Influence of Alcohol and DUI with a BAC Over .08; ticketed for Failure to Reduce Speed to Avoid an Accident. Resendis Corona was cited and released with her court information.
