A caller contacted 911 and stated they observed a Honda CRV (BX96137) driving erratically in the area of River Rd. and Central Rd. Officer's responded to the area and observed the above CRV to have a difficult time maintaining a lane, and struck a median. They activated their emergency overhead lights and approached the driver, Alvic Tabacon. While speaking to Alvic, officer's could smell the strong smell of an alcoholic beverage at which point Alvic was requested to perform Standardized Field Sobriety Tests. Alvic failed multiple tests, admitted to consuming alcohol, and was taken into custody. He was transported to DPPD for further processing and eventually release in accordance with Illinois Law.
