NOTEWORTHY INCIDENTS:

OFFENSE: Hit and Run Accident **DATE/TIME:** 05/05/2025 1:00 p.m.

LOCATION: Golf Road / Broadway Street

The victim, an Arlington Heights resident, was navigating the traffic circle at 1 Cumberland Circle in the inside lane passing Broadway Street while the Unknown Offender was attempting to enter the circle from Broadway Street. The offender failed to yield the right of way and entered the victim's traveling lane striking the passenger side the victim's vehicle. The offender then fled the area without leaving information in a gray Honda Accord and described as a female.

OFFENSE: Retail Theft

The Unknown Offenders entered the Jewel Osco located in the 1500 Block of S. Lee Street and proceeded to the liquor aisles of the store. Once there, the male white and female white placed two bottles of liquor in each of their backpacks. A store employee heard the bottles clinking together and followed the offenders to the north side door area where they attempted to leave the store and were past the last point of checkout. The employee grabbed the bags and were able to recover the liquor while the offenders fled the area south towards Oakton Street.

Des Plaines Police received an alert from FLOCK, an automated license plate reader, that a stolen vehicle, a black Honda Accord, was traveling northbound on Des Plaines River Road from Foster Avenue in Rosemont, IL. While responding towards the south side of Des Plaines, officers located the vehicle at Des Plaines River Road and Touhy

Avenue where they began to follow it. The vehicle turned west onto Oakton Street and into the Walgreens parking lot in the 1800 Block of E. Oakton Street. At that time, additional officers responded to the area in marked patrol vehicles and the Honda Accord began to exit the parking lot south onto Des Plaines River Road. The officer activated his overhead emergency lights to stop the vehicle, but it disobeyed the emergency lights and fled at a high rate of speed. While fleeing, the Honda reached speeds 40MPH above the posted limit and drove into oncoming traffic lanes just before entering the I-294 southbound ramp where the officers deactivated their emergency lights and stopped.

The Unknown Offender(s) were reportedly northbound on Mannheim Road approaching Frontage Road traveling at a high rate of speed and according to the victim, a 19-year-old Des Plaines resident was possibly racing with another vehicle. The victim had just turned north onto Mannheim Road from Frontage Road when he was rearended by an unknown black Audi SUV. The Audi then fled the scene without leaving information.

Des Plaines Police responded to the Rivers Casino located in the 3000 Block of S. Des Plaines River Road for the report of an unwanted subject. When the officers arrived, they contacted the identified subject, later known as Kevin Davis, standing near the Rivers Casino security staff. Security stated they were no longer allowing Davis to be on the property and wanted him cited for trespassing since he had been advised to leave and was refusing. The officers then spoke with Davis, who refused to provide identification, and told him that the security staff were not allowing him to remain on the property. Davis ignored the officer and continued trying to speak with security. Davis was given multiple chances to leave the property and his failure to do so would result in being issued a City Ordinance violation for Trespassing. Davis refused and was again asked for his identification for the citation when he stated that he was "sovereign" and refused to provide it. The officer informed Davis that his refusal to provide his information is obstructing his investigation and he would be taken into custody. Davis did not comply with the officers and was handcuffed. A search of his person resulted in finding a small container with a white powdery substance in Davis's left pant pocket, suspected of being cocaine.

Davis and the substance were both transported to the Des Plaines Police station where the substance was tested using a Narcotics Identification Kit. The test was positive for the probable presence of cocaine and weighed approximately 0.62 grams. Davis was still refusing to identify himself which resulted in the officers conducting a fingerprint inquiry and learning that he was Kevin Davis. Davis was subsequently arrested for one felony count of Possession of a Controlled Substance; one misdemeanor count each of Obstructing a Peace Officer and Criminal Trespass to Real Property. Davis was cited and released with his court information.

> Des Plaines Police responded to a hit and run accident at the intersection of Touhy Avenue and Mount Prospect Road on May 6, 2025, at approximately 7:28 p.m... The officer responding to the scene observed a Toyota Rav4 and a Hyundai Elantra both with rear end damage, the Hyundai also having front end damage. After speaking with the parties involved, it was learned that the Hyundai was traveling behind the Toyota, and they were both stopped at the red light on Touhy Avenue just west of Mount Prospect Road in the middle lane of traffic. A black Toyota sedan had failed to reduce speed and struck the Hyundai causing it to propel forward into the Toyota. After the accident, the black Toyota sedan fled the scene without providing information to either party left on scene.


At approximately 8:03 p.m., the Cook County Sheriff's Police Department notified officers that a black Toyota Camry, a vehicle matching the description of the vehicle that fled from the accident, was in the 500 Block of McKinley Avenue. CCSPD was called to the area regarding another accident where the Camry struck three parked vehicles. Officers responded to McKinley Avenue and observed the Camry with front end damage consistent with the damage that would have been caused due to the accident on Touhy Avenue. While speaking to the CCSPD officers, the subject (later identified as Cesar Caixba) began resisting being placed in handcuffs. Des Plaines officers assisted CCSPD with placing Caixba into custody and during that time, Caixba grabbed one of the officers' wrists and refused to let go. Caixba was eventually placed in handcuffs and remained in the custody of the CCSPD officers. It was then learned through running his information through the database that he did not have a valid driver's license, a license was never issued by the Illinois Secretary of State. The license plate inquiry for the Toyota Camry alerted officers that there was no valid registration, said registration was cancelled, suspended, or revoked by the Illinois Secretary of State.

Caixba was subsequently arrested for one misdemeanor count of Battery, Failure to Remain on Scene of a Vehicle Damage Accident, No Valid Driver's License, and the Operation of a Vehicle with Cancelled, Suspended, or Revoked Registration; ticketed for Improper Lane Usage, Failure to Reduce Speed to Avoid an Accident, Failure to Report a Vehicle Accident, and the Operation of an Uninsured Motor Vehicle. Caixba was cited and released with his court information.

Des Plaines Police were on patrol in the 2300 Block of S. Wolf Road when he noticed a black Dodge Charger on the roadway and was unable to read the rear license plate/registration due to the plate lite not being illuminated. The officer activated his overhead emergency lights and curbed the Dodge. After approaching the driver, later identified as Ramon Ramirez Rangel, he requested the driver's license and proof of insurance. Ramirez Rangel was only able to provide the officer with the insurance and his identifying information. The officer returned to his patrol vehicle and ran the information through the database and was alerted that Ramirez Rangel did not have a valid driver's license, said license was revoked by the Illinois Secretary of State. Ramirez Rangel was informed of the violation, asked to step out of the vehicle and was taken into custody. After being transported to the Des Plaines Police station, Ramirez Rangel was subsequently arrested for one misdemeanor count of Driving While Driver's License Revoked and ticketed for No Registration Plate Lite. He was cited and released with his court information.

On January 16, 2025, at approximately 11:36 p.m. Des Plaines Police Officers attempted to conduct a traffic stop on a black Mercedes-Benz without any registration in the 1700 Block of Miner Street.

When officers activated their emergency lights, the vehicle fled at a high rate of speed westbound on Miner St. Officers observed the vehicle disregarding several red lights as it fled. Officers continued to pursue the vehicle westbound on Northwest Highway to Kennicott Boulevard in Arlington Heights. As officers were able to get near the fleeing vehicle, the driver abruptly turned left, causing a police vehicle to strike it. Both the police officer and the offender were injured as a result of the accident. The driver of the fleeing vehicle, Donna Plodzien Dolezal, and the officer were transported to a local hospital, where they were treated for their injuries. Due to Plodzien's need for definitive medical care, the Des Plaines Police Department did not charge her at the time

of the incident.

After further follow-up investigation, Des Plaines notified the Vernon Hills Police Department of the incident and on May 2, 2025, they notified the Des Plaines Police Department that their officers had detained Dolezal. Des Plaines Police Officers took Dolezal into custody , and she was charged with six felony counts of Aggravated Fleeing or Attempting to Elude a Peace Officer – Rate of Speed at Least 21 MPH Over the Posted Limit, Causes Great Bodily Injury to any Individual, Causes Property Damage in Excess of \$300.00, Involves Disobedience of 2 or More Traffic Devices, Involves Concealing or Altering Vehicle's Registration Plate; one felony count of Aggravated Reckless Driving – Great Bodily Harm; one misdemeanor count of Speeding 35 MPH + Over the Posted Speed Limit; ticketed for No Front or Rear Registration Plate and Disobey a Traffic Control Device x2. She was cited and released with her court information.
