NOTEWORTHY INCIDENTS:

OFFENSE: Deceptive Practice
DATE/TIME: 04/17/2025 – 05/08/2025
LOCATION: 200 Block of N. Wolf Road

The Unknown Offender(s) called the victim, a 72-year-old male Des Plaines resident, identifying themselves as a representative from the Social Security office. The offender(s) informed the victim that there was illegal activity associated with one of his bank accounts. To avoid penalty, the victim was convinced to send a cashier's check to them in the approximate amount of \$97,600.00 to an address in Monterey, California. Following sending the check, via UPS, the victim's further communication with the offender(s) led him to believe that he had been deceived and he filed a police report.

Due to the recent increase in crime happening at the YMCA building located at 300 E. Northwest Highway, the following are reported incidents at that location:

Des Plaines Police responded to the 2000 Block of Ash Street for the report of a disturbance. Once on scene, officers met with the subject, Nanette Hall, in relation to the call for service. During conversation, Hall's information was obtained and ran through the database when officers were alerted that she had two warrants, one through the Kankakee County Sheriff's Police Department and the other through the Iroquois

County Sheriff's Police Department. Cook County Dispatch contacted and confirmed with both KCSPD and ICSPD that the warrants were valid and extraditable. Hall was informed of the violations, taken into custody, and transported to the Des Plaines Police station where she was subsequently arrested for the Issuance of a Warrant x2. Hall was later brought to a Cook County courthouse for a detention hearing.

On April 28, 2023, Des Plaines Police responded to the 2900 Block of Curtis Street for the report of a theft. When the officers arrived, they spoke with the caller who stated that they are the manager for the property at that location, the Buckhorn Estates Trailer Park, and between April 24 and 28, 2023, the Unknown Offender(s) stole multiple tools from the maintenance garage. The caller additionally stated that there were only three employees with access to the garage at that time, one of which was the subject, Jason Harper. The caller advised that she had called Harper who denied any knowledge of knowing where the missing items were. In total, the value of the tools was approximately \$1,700.00.

On April 29, Des Plaines Detectives along with officers conducted a search in an online database of pawned items and located a transaction on April 8, in Harper's name for a Dewalt Portable Car Jump Starter. The model/serial number on the starter matched that of one of the items reported stolen the previous day by the caller. This transaction was conducted at a pawn shop in Harvey, IL. The caller/employee attempted to arrange a meeting with Harper after this information was learned, however, he had stopped showing up to work. On May 15, another search online was conducted and a second transaction of multiple tools at the same pawn shop. All items were placed on hold with the pawn shop and Detectives responded to that location on May 22, to review the transaction. While there, surveillance of the transactions was available for viewing and for both transactions, a male subject, known to Detectives as Harper, is seen entering the store with the tools, pawning the items, and then leaving. The Detectives recovered the tools that were at the shop, and they were eventually returned to the Buckhorn Estates property.

Over the next few months, Detectives attempted to get in contact with Harper via traveling to his previously known addresses, all of which had negative results.

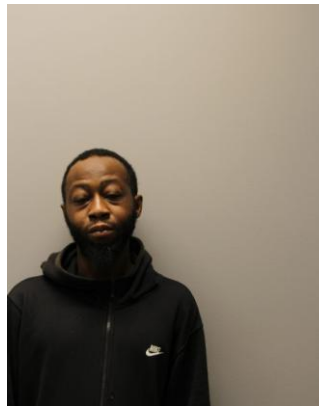
Detectives were able to speak with Harper over the phone on June 15 and advised that he needed to come into the station to return the property keys as well as speak with them regarding the incident. Harper refused to come into the station stating that he now lives in Indiana and will mail the keys if necessary. On July 10, Harper was again contacted by Detectives via phone and advised that he was being charged with theft and that he needed to come to the station to avoid an arrest warrant. Harper did not turn himself in and stopped responding to Detectives' phone calls. On August 14, Detectives went to

the Cook County courthouse and obtained an arrest warrant for Harper.

On May 8, 2025, the Chicago Police Department contacted Cook County Dispatch to advise that they had Harper in custody for a separate incident and verified the Des Plaines warrant was valid. After confirmation, Detectives travelled to the CPD district located in the 7800 Block of S. Halsted St. in Chicago, IL, and took custody of Harper. He was transported to the Des Plaines Police station for follow-up investigation. Due to the total value of the tools stolen, the Cook County State's Attorney's Office was contacted and approved of felony charges.

Harper was subsequently arrested for one felony count of Theft – Property Over \$500.00. He was later brought to a Cook County courthouse for a detention hearing.

Des Plaines Police responded to the 700 Block of Fifth Court for the report of a battery that had just occurred. When officers arrived on scene, they spoke with the victim, a 30-year-old female Des Plaines resident, who stated that she and the above subject, Michael Murawski, are in a dating relationship. On today's date, Murawski was upset and followed her into the kitchen where he jabbed at her hand with a fork causing it to puncture the skin. Officers spoke with Murawski who denied that he had done it and stated that the victim had done it to herself. After running Murawski's information, the officers were alerted that there was an active order of protection against Murawski on behalf of the victim.

Murawski was taken into custody and transported to the Des Plaines Police station where he was subsequently arrested for one misdemeanor count each of Domestic Battery and the Violation of an Order of Protection. He was later brought to a Cook County courthouse for a detention hearing.
