### **NOTEWORTHY INCIDENTS:**

**OFFENSE:** Aggravated Battery

**DATE/TIME:** 05/27/2025 8:35 p.m. – 9:24 p.m. **LOCATION:** 300 Block of W. Algonquin Road

The victim, a 41-year-old male Des Plaines, IL resident, was inside the tennis courts at the park located in the 300 Block of W. Algonquin Road when the Unknown Offender came into the court and punched him in the face. Shortly before the incident, a young male was kicking a soccer ball at the fence to the tennis courts when the victim asked him to stop. The offender, described as a Hispanic male with black hair, came into the court and punched the victim before fleeing on a bicycle.

The victim's vehicle, a silver Mercedes GLK, was parked on the roadway in the 1700 Block of Chestnut Street facing north while the Unknown Offender traveling southbound struck the front bumper after veering into northbound lanes. A witness to the incident stated that an older female was driving the offending vehicle described as a light-colored SUV. After the accident, the offender fled the area without providing

information.

Des Plaines Police responded to Miner Street and Western Avenue after receiving multiple 9-1-1 calls regarding a single vehicle accident in that area. When the officers arrived, they located a Volkswagen Tiguan approaching the curve in the 1000 Block of Northwest Highway traveling westbound when it left its lane of travel and struck the guard rail. As officers approached the vehicle, they located the subject, Mikheil Chichua, in the driver's seat. The driver's side window was rolled down and there was an odor of an alcoholic beverage emitting from within the vehicle. Officers began to ask Chichua questions about the accident, but he was unable to respond accurately as he did not know where he was nor was he aware that he was involved in an accident. The Des Plaines Fire Department was called to the scene to assess Chichua and his injuries at the time. The officers suspected that Chichua was intoxicated at the time of the accident but due to suffering a minor injury they did not request that he perform any tests. Chichua was transported by DPFD to a local hospital for his non-life-threatening injuries and subsequently arrested for one misdemeanor count of Driving Under the Influence of Alcohol; ticketed for Failure to Reduce Speed to Avoid an Accident, Improper Lane Usage, and Driver and Passenger Required to Use Safety Belts. Chichua was cited and released from the hospital with his court information.

Des Plaines Police responded to the Rivers Casino located in the 3000 Block of S. Des Plaines River Road for the report of unwanted subjects. Cook County Dispatch relayed to officers that the Rivers Casino was stating there were two subjects refusing to leave the premises. When the officers arrived, they located Casino Security who advised that



here were four subjects, two males and two females, being physically confrontational and argumentative with casino staff. Security escorted the officers to the location inside the casino where two females, later identified as Cheetara Banks and Monique Binion, were walking with an unknown male towards the cashier's cage. The officer stopped them and advised them they needed to leave the property. Binoin agreed and started to walk away yelling at officers, but Banks refused to leave. Banks was told several times by security as well as officers that she was no longer allowed on the property and needed to leave. In response, Banks became verbally aggressive and began getting closer to the officer. After repeated attempts to get Banks to leave and even allowing her to cash in her gaming chips, she still refused to comply with the officers' directions and was warned that further refusal to leave will result in her being arrested for trespassing. Banks continued to refuse and was ultimately escorted by the officers outside of the casino and placed in handcuffs.

While all of this was occurring, Binoin began approaching the area where officers were making their arrest and another officer assisted by making sure Binion did not interfere with the officers. Binion repeatedly made multiple advances towards the officers dealing with Banks and was instructed to stay back by the third officer when she then threw a water bottle at the officer, striking him in the arm. The officers then approached Binoin, took her into custody, and placed her in a patrol squad.

Both Binion and Banks were transported to the Des Plaines Police station where Banks was subsequently arrested for one misdemeanor count each of Criminal Trespass to Real Property and Disorderly Conduct. She was cited and released with her court information.

Due to the nature of the incident, the Cook County State's Attorney's Office was contacted and who approved a felony charge for Binion. Binoin was subsequently arrested for one felony count of Aggravated Battery to a Peace Officer. She was later brought to a Cook Count courthouse for a detention hearing.

Des Plaines Police responded to the 700 Block of W. Golf Road for the report of an unwanted subject, later identified as Juamarius Rogers, who was begging for money in front of a store. When the officers arrived, they located Rogers outside of the store who admitted that he was asking people for money. The officers then spoke with the complainant who advised that at one point he had come into the store and began asking people for money inside. When asked to leave, he became verbally aggressive with the staff. Rogers's information was obtained and run through the database which alerted officers that he had a warrant through the Cook County Sheriff's Police Department. Cook County Dispatch confirmed that the warrant was valid and extraditable when Rogers was advised of the violation, taken into custody, and transported to the Des Plaines Police station. Rogers was subsequently arrested for one count of the Issuance of a Warrant and later brought to a Cook County courthouse for a detention hearing.

On May 28, 2025, Des Plaines Police responded to the 1600 Block of Linden Street for the report of a disturbance. Once on scene, the officers spoke with the victim, a 23-year-old male Des Plaines, IL resident, who stated that he shares a dating relationship with the subject, Heaven Moore-Brown, and overnight they got into an argument which escalated when Moore-Brown slapped him. Both parties went to bed and then the next morning proceeded to engage in another argument. During this, Moore-Brown struck him in the face multiple times and bit him twice. The victim was able to free himself and call 9-1-1 when Moore-Brown stole \$250.00 from him and fled the scene prior to officers arriving. Officers were able to speak with Moore-Brown via cellphone who admitted to a physical confrontation and also to taking money from the victim. Moore-Brown agreed to come into the Des Plaines Police station the following day to talk about the incident further.

On May 29, 2025, Moore-Brown came into the station, she was taken into custody and escorted to a secure holding area. Moore-Brown was subsequently arrested for one misdemeanor count each of Domestic Battery and Theft. She was later brought to a Cook County courthouse for a detention hearing.
