NOTEWORTHY INCIDENTS:

The victim, a 64-year-old male Des Plaines resident, was northbound on Golf Road approaching the traffic circle at 1 Cumberland Circle in the inside lane while the Unknown Offender was exiting the traffic circle and traveling south on Golf Road in the inside lane. As the vehicles were passing, the offender crossed the center lane lines and struck the victim's driver's side mirror. The offending vehicle then fled the area without leaving information.

Des Plaines Police were conducting a premise check of the area in the 1500 Block of E. Miner Street when they observed an unknown subject, later identified as Steven Mack, lying on the cement near the front entrance to the train depot. The officers woke Mack to check on his well-being and requested his identification, to which Mack provided. Mack's information was then run through the database when Cook County Dispatch alerted the officers that he had a warrant through the Evergreen Police Department. CCD confirmed with EPD that the warrant was valid and extraditable when Mack was advised of the violation and taken into custody. Mack was then transported to the Des Plaines Police station where he was subsequently arrested for the Issuance of a Warrant and turned over to EPD.
