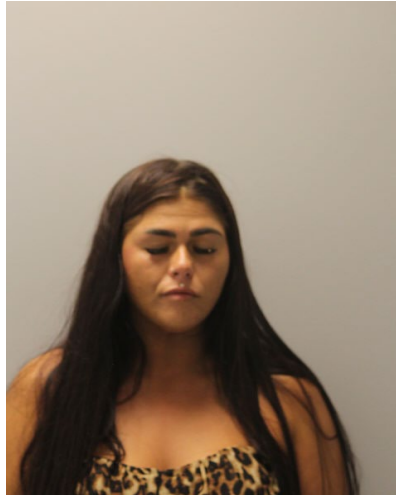

Officers spoke with the victim who relayed she and subject, Jesus Rodriguez, were having an argument, and he kicked her in the stomach. He then fled the scene. Officers located Jesus in the area, and he was taken into custody and transported to the station. Jesus was subsequently arrested for Domestic Battery. He was later transported to court for a pre-detention hearing.

Des Plaines officers responded to the 1400 block of Miner Street for the report of an intoxicated subject, later identified as Amber King. Officers spoke with the victim who stated Amber was asked to pay her bar tab and when her card was declined, she became aggressive toward the victim and struck him multiples times. Amber was taken into custody. Prior to being placed in the squad car, a search was conducted of Amber's person and purse. Officers located two small baggies containing a white powdery substance suspected to be cocaine and a single pill. Amber refused to get into the squad car, she tensed her body up and began resisting officers. She was eventually placed in the car and transported to the station. The suspect cocaine and pill were tested and tested positive for cocaine and Adderall. Amber was subsequently arrested for two counts of Possession of Controlled substance and one count of Resisting an Officer. She was also cited under Des Plaines City Ordinance for Battery, Trespassing and Theft. She was cited and released with her court information.

Des Plaines officers responded to the 600 Block of W. Millers Road for a check wellbeing. The caller relayed a vehicle was running and parked blocking his driveway with the driver appearing to be sleeping. Officers approached the driver of the vehicle, later identified as Selvin Lopez Ramirez, and observed him to be sleeping with an open bottle of beer in the center console. Officers woke Selvin up and requested him to exit his vehicle. He was unsteady on his feet and was swaying while standing. He was confused where he was and where he was traveling to. He also did not possess a valid driver's license. Officers requested Selvin to submit to Standardized Field Sobriety Tests which he did. He showed visible signs of impairment and was taken into custody and transported to the station. At the station he refused any further testing or questions. He was subsequently arrested for Driving Under the Influence of Alcohol and No Valid Driver's License. He was also cited for Illegal Transportation of Alcohol by Driver. He was cited and released from the station with his court information.
