Des Plaines Police responded to a disturbance in the 2000 Block of Spruce Avenue where the caller advised the above subject, Alexander Kunovszky, was violating a court order. When the officers arrived, they spoke with the complainant who stated that Kunovszky was served an order of protection previously and had come onto the protected property, violating the order. Officers obtained Kunovszky's information and ran it through the database which confirmed that the order was valid and had been served. Kunovszky was stopped in the driveway and admitted to knowing of the order but being on the property anyway. He was taken into custody and transported to the Des Plaines Police station where he was subsequently arrested for one misdemeanor count of Violation of an Order of Protection. Kunovszky was later brought to a Cook County courthouse for a detention hearing.

Des Plaines Police responded to the Rivers Casino located in the 3000 Block of S. Des Plaines River Road for the report of a fight in progress. While traveling to the area, Cook County Dispatch advised that the parties were now separated and to meet with security when they arrived. When officers were at the Casino, they were escorted to one of the victims, a 21-year-old male Park Ridge resident, who stated he and the other victim, a 21-year-old male Niles resident, were inside the Lotus Bar when they were approached by the male subject, later identified as Christian Llerena Sanchez. All parties engaged in a verbal dispute which escalated when Llerena Sanchez put one of them in a headlock and punched the other. The fight was broken up by security shortly after this occurred. Security footage of the incident was seen which verified the victims' account of the incident. It was then reported that during the altercation, a four-foot glass wall was cracked inside the casino.

Llerena Sanchez was taken into custody and transported to the Des Plaines Police station where he was subsequently arrested for two misdemeanor counts of Battery and one misdemeanor count of Criminal Damage to Property. He was cited and released with his court information.
