CRIME REPORT

Des Plaines officers responded to the area of Oakton Street and Chestnut Street for a traffic crash. Officers identified the driver of one involved vehicle as Stacey Chaput. She exhibited signs of impairment, including the odor of alcohol, slurred speech, and bloodshot eyes. After refusing field sobriety testing, she was placed under arrest for DUI. Stacey was transported to the Des Plaines Police Department, where she was charged with Driving Under the Influence of Alcohol, Failure to Reduce Speed, and Driving Without a License on Person. Stacy was released with her court information.

Des Plaines officers responded to the area of Rand Road and Miner Street for a hit-and-run crash. The caller reported her vehicle, a purple Dodge Challenger, struck a black Nissan Sentra that then fled north on Rand Road. Officers observed front-end damage to the Dodge, and the caller provided a photo of the fleeing vehicle and its registration. A registration check identified the Nissan's owner as Marissa Robertson. Officers located the Nissan parked at an address in Glenview with fresh rear-end damage. Contact was eventually made with Robertson, who admitted she left the scene because she was scared. Robertson was taken into custody and transported to the Des Plaines Police Department. She was charged with Failure to Remain at the Scene of a Vehicle Damage Accident and was provided her court information.
