A Des Plaines Police officer responded to a park facility in the 300-block of West Algonquin Road for a report of graffiti on a sign. The officer observed the west side of the sign spray-painted with the words "FART TOWN" in red. An evidence technician documented the damage, and park district staff were notified for removal. The officer noted similar graffiti incidents previously reported in the city.

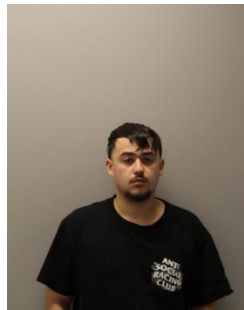
