
ABOUT US

The Gun Violence Prevention Initiative, housed in the Lake County State's Attorney's Office, is one of only five of the like in the country. By grounding the work in the pillars of (1) evidence-based approaches, (2) trauma informed practices and (3) community-grounded engagement, the GVPI's vision is to, "interrupt cycles of violence through the use of evidence-based practices that rely on collaborative approaches in meeting the needs of people who have been harmed or are at risk of being harmed." The pieces that comprise the GVPI are six: Firearm Risk Reduction, Youth Engagement, Resource Ecosystem, Intervention (Community Violence Intervention), Victim Services, and Restorative Justice.



Achievements in GVP in Lake County

One of the priorities of the GVPI is to track gun violence in Lake County to assess where intervention and services are most needed. Gun violence steadily continues to decrease in our county each year. In 2024, Lake County gun violence homicides decreased by 30 percent from 2023. We look forward to tracking more downward trends every year.



2024 Total Homicides in R3 Zones: Zion: 4 | Waukegan: 5 | North Chicago: 0



In 2024, there were a total of **14 firearm homicides** in Lake County. In 2023, there were 20 firearm homicides. This indicates a continued decline in firearm homicides from 2022, which were 38.



Lake County is **beating** the national average for Firearm Homicide Decreases.



Pieces of the GVPI "Puzzle"

This piece focuses on raising community awareness about safe firearm storage and leads community education and support on Firearm Restraining Orders (FROs) and Clear & Present Danger Reports.



What We've Accomplished:

- Lake County named the statewide leader of FROs per capita
- Partnered with jurisdictions across the country engaging in similar gun violence prevention work:
 - Johns Hopkins University ERPO Center
 - University of Colorado, Boulder Gun Violence Research Center
 - o Illinois State Police
 - Illinois Attorney General
- GVPI distributed over **4,000 gun locks** across the county

What You Can Look Forward To:

- FRO guideline pocket cards for law enforcement, physicians, & social workers
- More gun lock distribution sites
- Firearm Safe Distribution Program
- More trainings across the county

What We Can Provide:

- FRO trainings
- FREE Gun Locks

This piece focuses on providing services to people who have been affected by gun violence, as well as those navigating the legal system as a result of violent crime. Victim Services (VS) within the GVPI is unique in its ability to serve victims and survivors of gun violence, specifically. The VS team is holistic in its approach and goes beyond court advocacy by connecting people to support services in the community.

What We've Accomplished:

- Held a vigil for people who have been lost to gun violence
- Hosted Townhalls to assess needs for community healing

What You Can Look Forward To:

- Homicide Survivor's Support Group
 - every 2nd Wednesday of the month
- More community healing events

What We Can Provide:

- Individual and Family Therapy
- Court Advocacy

VICTIM SERVICES

This piece focuses on engaging youth by providing mentorship services that utilize storytelling and spoken word poetry to provide healthy outlets for self-expression. The flagship programs highlighted in this piece are, "My Brother's Keeper's Alliance" (MBK) & "Our Greatness is Our Story."



What We've Accomplished:

- MBK Programs in 6 schools
- Of 99 participants in 2023, every MBK senior graduated.
- Apprenticeship Programs with Aeon Credit Union, Granger, Lake County Workforce Development Board
- 109 Total MBK Participants
- 22 Lake County Teachers involved in MBK programming

Pieces of the GVPI "Puzzle"

This piece works to establish and maintain an ecosystem of resources for the residents of Lake County. The Violence Prevention Coordinating Council (VPCC) forms essential partnerships with community-based violence prevention organizations and connects them to those affected by gun violence (or those at risk to gun violence).



What We've Accomplished:

- A coalition of 49 organizations in Lake County
- Monthly Convenings to discuss gaps and share resources

What You Can Look Forward To:

- A Resource/Asset Map of organizations in Lake County that provide essential services
- Committees that address Youth Engagement, Community Engagement, & Victims Services
- More Community Events centering Gun Violence Prevention

What We Can Provide:

- Access to Referral Network of organizations in Lake County
- Opportunities for Trainings

The purpose of this piece, and of the State Attorney's Office in general, is to invest in alternatives to arrest and incarceration for non-violent offenses through a focus on accountability measures and repairing harm.

What We've Accomplished:

- Initiated Prosecutor-Led Diversion programs
- Partnered with VPCC organizations to pilot diversion programs
- Partnered with Specialty Courts

What We Can Provide:

- Presentations about <u>Diversion/Deflection</u>
 Programs
- Legal Expertise about how organizations can implement diversion programs
- Provide Connections to Restorative Justice Experts and Trainings



What You Can Look Forward To:

- Hiring a Diversion Coordinator
- Scaling both misdemeanor and felony diversions
- Deflection Trainings

This piece, known as, "Community Violence Intervention," is managed by the Lake County Peacemakers. This team works to, "interrupt the cycles of violence by building trust with the community, mediating disputes, preventing retaliation, and engaging with high-risk individuals." Their prominence and efficacy in the community speaks for itself, as the correlation between their influence and the decrease in homicides in Waukegan, North Chicago, and Zion should not be ignored (see graphics on page 2).



What We've Accomplished:

- Hired a team of 15 Lake County Peacemakers
- Built rapport and trust within LC communities
- Played an essential role in the decrease in homicides in Waukegan, North Chicago and Zion

- Expanding the team
- A Prominent Presence on Social Media

What We Can Provide:

- Conflict Resolution and Mediation
- Response to incidents of gun violence within 90 minutes
- Case Management for High-Risk Individuals
