DEFAULT JUDGMENT

The Plaintiff, State of Indiana, having filed its Motion for Default Judgment and the Court having read the same and being duly advised in the premises, now finds:

- The Court has subject matter jurisdiction and personal jurisdiction over the Defendants.
- The Plaintiff provided the Defendants with proper notice of these proceedings through service by certified mail at 2015 E Broad Ripple Ave, Indianapolis, IN 46220.
- 3. The Defendants failed to plead or otherwise respond in this action.
- 4. Defendant Naim Mahmoud is not an infant, incompetent, or in the military service.

RELIEF

- 5. IT IS ORDERED, ADJUDGED, AND DECREED the Motion for Default
 Judgment is GRANTED in favor of the Plaintiff, State of Indiana, and against
 the Defendants. Judgment is entered for the Plaintiff, State of Indiana, and
 against the Defendants Capitol Motors LLC and Naim Mahmoud, for the relief
 described in Paragraphs 6 through 12 of this Order.
- 6. Judgment is entered in favor of the Plaintiff and against Naim Mahmoud for a permanent injunction under Ind. Code § 24-5-0.5-4(c)(1), enjoining Naim Mahmoud from owning, operating or managing any aspect of motor vehicle dealership located in Indiana.
- 7. Judgment is entered in favor of the Plaintiff in the form of an Order directing the Indiana Bureau of Motor Vehicles to issue titles to the following consumers and their respective vehicles:

8. Judgment is entered in favor of the Plaintiff and against the Defendants for consumer restitution under Ind. Code § 24-5-0.5-4(d) and Ind. Code § 9-32-16-2(e), in the amount of sixty-two thousand, four hundred eighty dollars (\$62,480.00), payable to the Office of the Attorney General, for the benefit of

- consumers in the specific amounts referenced in Exhibit 1, which is attached to this Judgment.
- 9. Judgment is entered in favor of the Plaintiff and against the Defendants for costs under Ind. Code § 24-5-0.5-4(d)(3), awarding the Office of the Attorney General its reasonable expenses incurred in the investigation and prosecution of this action in the amount of four hundred fifty dollars (\$450.00).
- 10. Judgment is entered in favor of the Plaintiff and against the Defendants for civil penalties under Ind. Code § 24-5-0.5-4(g), for the Defendants' knowing violations of Ind. Code § 24-5-0.5-3(a), Ind. Code § 24-5-0.5-3(b)(1), and Ind. Code § 24-5-0.5-3(b)(8), in the amount of five thousand dollars (\$5,000.00) per violation, with 31 violations, for a total penalty amount of one hundred fifty-five thousand dollars (\$155,000.00), payable to the State of Indiana.
- 11. Judgment is entered in favor of the Plaintiff and against the Defendants for civil penalties under Ind. Code § 24-5-0.5-8, for the Defendants' incurable deceptive acts, in the amount of five thousand dollars (\$5,000.00) per violation, with 31 violations, for a total penalty amount of fifteen thousand, five hundred dollars (\$15,500.00), payable to the State of Indiana.
- 12. Judgment is entered in favor of the Plaintiff and against the Defendants for civil penalties under Ind. Code § 9-32-17-1 for the Defendants' false, deceptive and misleading advertising and deceptive acts and practices, in the amount of ten thousand dollars (\$10,000.00), payable to the State of Indiana.

A total monetary judgment in the amount of two hundred forty-three thousand, four hundred thirty dollars (\$243,430.00), plus court-ordered titles shall be entered in favor of the Plaintiff, State of Indiana, and against the Defendants, Capitol Motors LLC and Naim Mahmoud.

Additionally, Defendant Naim Mahmoud is enjoined from engaging in the conduct referenced in Paragraph 6, above.
