The Court enters Final Judgment in this cause as follows:

Judgment is entered in favor of Defendants in their official capacities and against Plaintiffs Planned Parenthood of Indiana and Kentucky, Inc., and Carol Dellinger, M.D., as to their claims concerning the following provisions of House Enrolled Act 1337:

- the anti-discrimination provisions, Indiana Code §§ 16-34-4-4, 16-34-4-5, 16-34-4-6, 16-34-4-7, 16-34-4-8;
- the information dissemination provision, Indiana Code § 16-34-2-1.1(a)(1)(K); and

- the fetal tissue disposition provision, Indiana Code §§ 16-21-11-6, 16-34-3-4(a), 16-41-16-1, 16-41-16-4(d), 16-41-16-5, 16-41-16-7.6.

Judgment is entered accordingly, and this action is **TERMINATED**.
