

2019–2020 AIR Training Schedule for Indiana Schools

The Indiana Department of Education (IDOE) and American Institutes for Research (AIR) are pleased to announce the schedule of systems trainings for the 2019–2020 school year. Indiana school personnel involved with the *ILEARN*, *IREAD-3*, *I AM* and/or *ISTEP+* assessments have several opportunities to develop knowledge of and gain proficiency with AIR’s online systems to support test delivery and implementation.

REQUIRED Online Training

All licensed school personnel planning to administer *ILEARN*, *IREAD-3*, and/or *ISTEP+* assessments **must** complete the Test Administrator Certification Course before they will be able to initiate online student assessments in the online system. School personnel who do not complete this training cannot start test administration sessions for their students. IDOE recommends this training be completed within four weeks of the test administration window to retain key details for implementation. Registration within AIR’s TIDE system is the only requirement for this course, which will be located on the [Indiana Assessment Portal](#) beginning September 23.

All licensed school personnel planning to administer *I AM* assessments **must** complete the *I AM* Test Administrator Certification Course, which includes three modules and one quiz, before they will be able to initiate student assessments in the online system. School personnel who do not complete the training modules and the quiz cannot start test administration sessions for their students. Registration within AIR’s TIDE system is the only requirement for this course, which will be located on the [I AM Assessment Portal](#) beginning March 9.

First-Year Test Administrators **must** attend a live webinar in addition to completing the *I AM* Test Administrator Certification Course.
