<p>Understanding I AM Webinar Posted to Portal <i>The Understanding I AM Webinar provides an overview on the I AM Assessment. It will be available on AIR's Indiana Assessment Portal.</i></p>	10/1/19
<p>2019-2020 Released Items Repository (RIR) Posted to Portal <i>Schools can access all current Released Items for I AM. The Released Items Repository link is available through AIR's Indiana Assessment Portal. Additional items have been added for the 2019-2020 school year.</i></p>	10/1/19
<p>Systems Readiness Test (SRT) <i>All schools are required to participate in a SRT to ensure testing devices and local network setup are prepared for testing. Schools who participate in the early SRT date for winter testing are <u>not</u> required to participate again in the later window.</i></p>	11/18/19-11/27/19
<p>I AM Test Administrator Training Registration for New I AM TAs <i>IDOE and AIR will host training webinars for new I AM TAs. The training will cover the most important aspects of administering I AM and is a requirement of all TAs who did not complete the live I AM training for the 2018-2019 school year. All I AM TAs will be required to complete the online course in TIDE. Completion of the online course is what certifies a TA to administer I AM. Webinar registration is available via the I AM Portal.</i></p>	12/2/19
<p>Print and Large Print Accommodated Materials Deadline <i>Print and large print paper accommodations must be noted in the student's IEP by 12/20/19. Please note, if a print or large print paper accommodation is marked in IIEP, this form will be shipped to the corporation.</i></p>	12/20/19
<p>Braille Accommodated Materials Deadline <i>Braille accommodations must be noted in the student's IEP by 1/30/20. Please note, if a braille paper accommodation is marked in IIEP, this form will be shipped to the corporation. Braille forms cannot be ordered during the Additional Materials Window.</i></p>	1/30/19
<p>I AM Test Administrator Training for New I AM TAs <i>IDOE and AIR will host training webinars for new I AM TAs. The training will cover the most important aspects of administering I AM and is a requirement of all TAs who did not complete the live I AM training for the 2018-2019 school year. TAs will still be required to complete the online course in TIDE. Completion of the online course is what certifies a TA to administer I AM.</i></p>	2/24/20-3/10/20
<p>I AM Test Administrator Training and Certification – Online Course Deploys <i>The online course is a requirement of all I AM TAs. This course is different from the ILEARN training. If TAs will administer both assessments, they must complete both online courses. TIDE will now indicate if a TA is certified to administer I AM so that CTCs and STCs can ensure all TAs are properly certified.</i></p>	3/9/19

<p>LCI (Learner Characteristics Inventory) Window Opens for Test Administrator Completion</p> <p><i>The LCI must be completed for each student taking the I AM assessment. It is a prerequisite for the practice and operational assessments. The LCI window will close the same day the test window closes, May 15, 2020.</i></p>	3/16/20
<p>I AM Test Administrator's Manual (TAM) and Test Coordinator's Manual (TCM) Posted to Portal</p> <p><i>The I AM Test Administrator's Manual (TAM) and Test Coordinator's Manual (TCM) is available on AIR's Indiana Assessment Portal. These documents detail how to successfully administer the I AM assessments.</i></p>	3/20/20
<p>I AM Q&A Sessions for Educators</p> <p><i>IDOE and AIR will host two Q&A sessions for educators to address any questions regarding the administration of I AM prior to the opening of the operational window. These webinars will be a half hour in length. Registration will be available via the I AM portal.</i></p>	3/26/20-3/30/20
<p>Additional Window to Flag Students for Accommodations and Ship Materials</p> <p><i>Additional Accommodated Materials will be shipped for those students who were not accounted for in the Initial Ordering Window. Please note, braille forms cannot be ordered after 1/30/20.</i></p>	3/30/20-5/6/20

<p>Test Window Dates</p> <p><i>All required assessments must be administered during this window. Students may be assessed at any point during the window. All online tests must be administered through the Student Interface via the Secure Browser by May 15, 2020. All TA should verify student accommodations in TIDE by April 6, when the window opens.</i></p>	4/6/20-5/15/20
<p>Invalidations Window</p> <p><i>CTCs and STCs can create invalidation requests in TIDE in instances where online testing may deviate from the standard testing process. For more info on Invalidation's please refer to TIDE User Guide.</i></p>	4/6/20-5/15/20
<p>Participation Reports Deploy</p> <p><i>Test Coordinators and Administrators can track test administration progress in TIDE.</i></p>	4/6/20
