Subject: Curricular Material Reimbursement

The Office of School Finance has calculated the 2022-2023 curricular material reimbursement payment to qualifying schools and charter schools. The payment is based on a per student amount using the formula outlined in Indiana Code 20-33-5-9.5. The appropriation for this program was completely expended with this distribution. The per student funding amount is approximately \$80.55. The estimated payment by school is listed below.

An electronic funds transfer for reimbursement will be paid Friday, February 24, 2023. A deposit notification will be sent to your treasurer prior to payment.
