

Identified ELs not included on the Pre-ID file can be added and registered for testing. Existing students' demographic data and test registrations can be edited, as needed.	Wednesda
Initial Materials Orders Arrive Initial materials arrive in corporations and schools. Initial materials are populated based on Pre-ID data.	Monday, J
