Project ECHO: Tele-mentoring Program for the Treatment of Opioid Use Disorder

Clinicians who care for patients in a rural setting face unique challenges related to opioid use disorder (OUD). Often, access to specialty care is minimal, patients have fewer resources than in urban environments, and significant cultural and demographic factors can impact all aspects of clinical care.

Reducing the burden of OUD is a critical individual and public health need. While behavioral and pharmacological therapies exist for OUD, treatment has been out of reach for many patients because too few health care professionals in rural communities are trained to treat OUD.

Project ECHO (Extension for Community Healthcare Outcomes) increases access to OUD care in rural communities by bringing together specialists and non-specialists through a web-based platform.

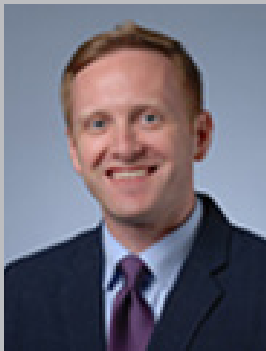
